Do not consult, confer or talk with any other person in completing this questionnaire.

If you are unable to answer a question because you do not understand the question, please write "Do not understand" in the space after the question. Do not ask anyone, including court personnel, for clarification or assistance.

If you are unable to answer a question because you do not know the answer, please write "Do not know" after the question.

If you believe that your response to a particular question is of an especially sensitive or private nature and request that your response not be made public, please write the number of that question in your response to Question #51. Alternatively, if you would prefer not to write an answer to a particular question because of the especially sensitive or private nature of your response, please write "Private" after the question. The Court may still need to inquire about the topic, but will endeavor to do so bearing your concerns in mind.

Please do not write on the back of any page. Use the blank space at the end of the form (front side only), where there is insufficient room on the form for your answer to any question. When using this space, please include the number of the question(s) you are answering.

You will be permitted to leave for the day when you have completed the questionnaire. After you leave, do not discuss, by any means, any of the questions or your answers on this questionnaire with anyone, including members of your family, co-workers or other potential jurors. If anyone approaches you and attempts to discuss any aspect of this questionnaire, the jury selection process or any aspect of this case, you may not answer their questions.
