### Narrative 1 - Battery - Original Report

On 12/02/2016 at 0314 hrs, I responded to 423 W. College Avenue in reference to a fight. Upon arrival, there was a large group of people standing on the sidewalk in front of the Pi Kappa Phi Fraternity house. As officers approached the crowd quickly dispersed, some of which went inside of the fraternity house and others that began walking east on W. College Avenue.

I made contact with the subjects who were walking east and identified them as Enrique Aguayo and Ryan Izzo.

Aguayo advised that he was "jumped" while walking down the street.

He stated that as he was walking members of the Pi Kappa Phi Fraternity were sitting on their front porch and began yelling at him.

He said that they were giving him a hard time about missed field goals during the Florida football game.

He said that he was rushed by several of the members of the fraternity and that they had "jumped" him.

He said he was punched in the face and various other places on his body.

Aguayo said that he had someone call Izzo and he came to the scene to help him get home.

Aguayo said he did not need EMS and that he would have the "trainers" look at his nose.

He stated that he did not want to press charges and refused to provide a written statement.

I did observe redness to Aguayo's face and nose and there was a moderate amount of blood on his face and shirt.

His injuries were consistent with being punched in the face.

His shirt was also ripped.

Izzo stated that he was called by Aguayo to help him because the members of the fraternity had "jumped" him.

Izzo stated that he did not witness anything and that the fight was over when he arrived.

Izzo stated that he just came to help Aguayo get back home.

Izzo refused to provide a written statement.

Contact was also made with the witnesses of this incident.

They were identified as Kameron Ouellette and Andrew Walter.

Ouelette and Walter were on their way home, driving east on W. College Avenue.

Ouelette stated that he had to stop because there was a group of people blocking the roadway.

Ouellette said he saw a tall man with a beard and black hair (unknown suspect) hit another guy with a blue shirt and very long hair (Aguayo).  
Ouelette said they continued to fight and the unknown suspect threw Aguayo onto his car (2010 Ford Fusion FL Tag# DNJ8Q).  
Ouellette and Walter got out of their vehicle and attempted to break up the fight.  
Ouellette stated that he observed a dent above the front left wheel of his vehicle where Aguayo was thrown.

Contact was then made with Nicholas DeSantis who is a member of the Pi Kappa Phi Fraternity.  
He stated that he heard about the fight outside of the residence.  
DeSantis stated that when he walked outside he was immediately called a "sorority fagget" and he was "hit in the face four times".  
He said that he found out that the "suspect" was "Roberto Aguayo" after he saw Aguayo leaving the property and DeSantis was on the ground.  
He stated that "the man in the teal shirt" (Izzo) also hit him and threatened the past president.  
DeSantis did provide a sworn written statement.

Ofc. E. Scarbrough #798 interviewed DeSantis.  
Scarbrough described the only visible injuries to Desantis being a slight red mark under his left jaw.  
He advised that DeSantis appeared to be intoxicated and that his injury was not consistent with being punched.  
DeSantis' injury was consistent with that of someone who had been wrestling someone else.  
DeSantis had pine straw on his pants leg consistent with the ground in front of the fraternity house.

No persons involved in this incident requested any medical attention.  
Furthermore, no persons involved in this incident wanted to press charges.

Florida State University Police were contacted and responded to the scene.  
Ofc. P. Adams #439 and Ofc. D. Sherer #444 responded and made internal notifications of the incident (FSU PD Case # 1612-0013).
