Ms. Brow is not a Hollywood person like you are. She is just the daughter of a murder victim. Nevertheless, we believe that victims matter.

Her mother was not just a name, and was not and is not a person who should be used as a line in a script or just a way to make a profit for the entertainment industry. She was a very special human being and an essential member of their family. She worked hard every day to support them in every way possible.

We would like to have a meeting with you and others from the film, so that she can obtain answers to her many questions and share the pain she feels because of her mother's murder and the fact that she has been ignored and never contacted about the making of this film.

She cannot say whether or not Kenneth Waters was a victim but she knows to a certainty that her mother was.

It is not too late to meet with her to show them the compassion that we think all family members of a murder victim deserve.
