Declaration of Norma Paula De Ahlf

- I, Norma Paula De Ahlf, am the person asking for protection. If called upon to testify, I could and would testify competently to the following: 3
 - 1. My name is Norma Paula De Ahlf. My date of birth is May 28, 1969. Originally from Brazil, I have lived in the United States for ten years. I came to the United States with my ex-husband. At the time, he came to UCLA to get his PHD.
 - 2. I met Monica Burgos in 2001 through a mutual friend. Our mutual friend was working at Monica's Brazilian restaurant, Zabumba, in Culver City. The address of Zabumba is 10717 Venice Blvd. Culver City, CA 90034. Our mutual friend was the bartender at Zabumba and asked me to come and meet her boss, Monica Burgos.
 - 3. I liked Monica from the moment I met her. As we were both from Brazil and loved to talk a lot, we have a lot in common. As such, we became fast friends.
 - 4. Within a few months, I was working at Zabumba. I was responsible for opening and closing the restaurant, taking inventory, and handling some of the accounts receivable.
 - 5. I worked at Zabumba from 2001-2004. I left to work at another Brazilian restaurant from 2004-2007.
- 6. I returned to Zabumba in 2007 and have been working there ever since. I became the general manager for Zabumba and am currently responsible for the daily operations of the restaurant. Monica was the owner of the restaurant and also involved in the daily operations however, because she wanted to spend time with her young children, I became the person most responsible for running the restaurant. I am aware of all of the bank accounts and the financial condition of the business
 - Monica has two children ages 5 and 3. She was married to Bruce Beresford-Redman for eleven years.
 - 8. On April 5, 2010, Monica went missing while vacationing with her husband and children in Cancun, Mexico. Her body was found three days later, on April 8, 2010 in a sewage pipe on the grounds of the resort at which she and her family had being staying. Her dotth was determined to be a homiside. Her husband Bruss has been staying. Her death was determined to be a homicide. Her husband, Bruce, has been the only suspect since the investigation began. It is my understanding that as of the date of this declaration, the Mexican authorities have issued a warrant for his arrest.
 - 9. Prior to her death, Monica was having problems in her marriage and would often confide in me the most intimidate details of their martial strife. For example, Monica shared with me that Bruce had been having an ongoing extramartial relationship with another woman. She shared with me that she was monitoring his emails and phone calls to the other woman. She shared with me that although Bruce and his father, David, did not have a strong relationship, they were spending a lot of time together, speaking on the phone several times a day. Monica shared with me her concerns that Bruce and his father, David, were planning something. Monica also shared with me that Bruce and his father, David, had taken approximately \$25,000.00 out of Monica and Bruce's joint account to pay for an outstanding debt incurred by Bruce's father, David. Monica also shared with me that Bruce and his father, David, took additional money from Bruce and Monica's joint account and he was the state. money from Bruce and Monica's joint account and bought either stocks or bonds in Bruce's name alone.

- 11. Several weeks before their trip to Mexico, Monica told me that she was going to withdraw a lot of money from their joint account. In the following several days, she withdrew the money, she changed the locks of their house and threw Bruce's clothes in trashbags and out onto the street.
- 12. She then took her children to Hawaii for several days to figure out how to handle her martial problems and decide whether or not to leave Bruce.
- 8 13. Bruce constantly called Monica in Hawaii, trying to convince her to take him back.
 - 14. When Monica and the kids returned from Hawaii, Bruce was at the house.

- 15. Despite all of their problems, Monica cared deeply for Bruce and wanted to have her family together. So, when Bruce suggested that they go on a family trip to Mexico, she agreed. Bruce made the reservations, he chose the hotel and completely planned the trip.
- 13 16. I told her not to go on the trip because it was not where she wanted to travel to and I was extremely suspicious that he would make travel arrangements since in their eleven years of marriage, he had never planned a vacation or made the travel arrangements, Monica always did.
- 17. Monica called me on April 30th, the day before they left for their trip to Mexico.
 That was the last time that I spoke to her.
- 17 18. Since her death, I have been running the restaurant with the help of her sisters, Carla and Jeane. Bruce and his father, David, have never had anything to do with Zabumba. I would approximate that Bruce has been to the restaurant less than once a month for the seven years that I have been working there. Bruce's father, David, has been to the restaurant less than four times per year in all of the time that I have worked there.
 - 19. On May 29, 2010, at 10:00 p.m., I was working at Zabumba. The restaurant was closed that day as I was preparing food for the memorial service we were holding for Monica the following day. The doors were shut, the lights outside were turned off and the sign said closed. We were not open for business. There were only a couple of us in the restaurant at the time. My car, which is known to Bruce and his father, was the only car parked next to Zabumba. Further, neither Bruce nor his father, David, would have any need either business or personal for being at the restaurant. Monica's sisters were recently granted temporary guardianship over the restaurant.
 - 20. I was preparing the food in the kitchen when Bruce's father opened the front gate of the restaurant and also opened the door to the restaurant. He walked into the restaurant with his right hand inside of his shirt, as if he was hiding a weapon.

21. He asked another one of the people helping us that day, in a very threatening way, "Where is Norma? I want to talk to Norma." He was very demanding. The employee came into where I was standing and was literally shaking. She told me that Bruce's father was there looking for me. 22. Bruce's father demanded that he speak to me. I am afraid of him and fear that he will harm me because of all of the information I have regarding his son and Monica. He has caused me severe emotional distress as I keep reliving the moment when he was staring me down with his hand in his shirt as if he was hiding a weapon. I truly thought that he was going to shoot me. I fear that if I do not have a restraining order against him, he will attempt to harm me in some way. If this order is imposed, David Beresford-Redman will still be able to get to his home and go about his daily business without interruption. - I, Michael Melair, am a witness to this action. If called upon to testify, I could and would testify to the following:
- 1. My name is Michael Melair and my date of birth is March 20, 1963,
- 2. I am a friend of Norma Paula De Ahlf. On May 29, 2010, I went to Zabumba to help Norma prepare for Monica's memorial the following day.
- 3. At about ten p.m., I was back in the kitchen cleaning some of trays when I heard someone said, "Michael, can you get this guy to leave?" I walked into the front kitchen area when I saw an older man standing there with his right hand in his shirt. It looked to me that he was holding a gun. I immediately became concern that he would physically harm or shoot one of us.
- 4. I walked up to him and told him that we were closed and he said, "Is Norma here?" He looked around to the kitchen area again repeating, "Is Norma here? I want to talk to Norma." When he saw her, he stated, "I want to talk to Norma." During the entire exchange, he had his hand in his shirt as if he was concealing a weapon.
- 5. Bruce's father, David, created such panic in the restaurant that everybody started yelling and screaming for him to get out of the restaurant. Bruce's father, David, left the restaurant soon thereafter. I immediately called 911.
