9 The Defendant above named having committed the crimes of DRIVING AND/OR
10 BEING IN ACTUAL PHYSICAL CONTROL WHILE UNDER THE INFLUENCE OF
11 INTOXICATING LIQUOR (Misdemeanor - NRS 484C.110, 484C.400); SPEEDING
12 (Misdemeanor - NRS 484B.600); IMPROPER TURN (Misdemeanor - NRS 484.343(1),
13 CCO 14.32.040); DRIVING WITHOUT A VALID LICENSE (Misdemeanor - NRS
14 483.550) and OPERATION OF MOTOR VEHICLE WITHOUT SECURITY (Misdemeanor
15 - NRS 485.185, 485.360), in the manner following, to-wit: That the said Defendant, on or
16 about the 10th day of October, 2010, at and within the County of Clark, State of Nevada,

17 COUNT 1 - DRIVING AND/OR BEING IN ACTUAL PHYSICAL CONTROL WHILE
18 UNDER THE INFLUENCE OF INTOXICATING LIQUOR

19 did then and there wilfully and unlawfully drive and/or be in actual physical control
20 of a motor vehicle, on a highway, or on premises to which the public has access, to-wit:
21 Spanish Trail Lane and West Tropicana, Las Vegas, Clark County, Nevada, while under the
22 influence of intoxicating liquor to any degree, however slight, which rendered him incapable
23 of safely driving and/or exercising actual physical control and/or while he had a
24 concentration of alcohol of .08 or more in his blood or breath, and/or when the Defendant
25 was found to have a concentration of alcohol of .08 or more in his breath sample which was
26 taken within two (2) hours after driving and/or being in actual physical control of said
27 vehicle.

1 COUNT 2 - SPEEDING

2 did then and there wilfully and unlawfully operate a motor vehicle, on Spanish Trail
3 Lane and West Tropicana, Las Vegas, Clark County, Nevada, by traveling at a speed of 72
4 miles per hour in a zone posted 45 miles per hour, at such a rate as to endanger life, limb or
5 property of any person.

6 COUNT 3 - IMPROPER TURN

7 did then and there wilfully and unlawfully operate a motor vehicle, at the intersection
8 of Spanish Trail Lane and West Tropicana, Las Vegas, Clark County, Nevada, in executing a
9 left turn without first entering the extreme left lane and failing to make said left turn as close
10 as practicable to the left hand curb or edge of said roadway.

11 COUNT 4 - DRIVING WITHOUT A VALID LICENSE

12 did then and there wilfully and unlawfully operate a motor vehicle, on Spanish Trail
13 Lane and West Tropicana, Las Vegas, Clark County, Nevada, without first being the holder
14 of a valid driver's license.

15 COUNT 5 - OPERATION OF MOTOR VEHICLE WITHOUT SECURITY

16 being the owner or driver of a motor vehicle registered in the State of Nevada, or the
17 owner or driver of a motor vehicle not registered, but present in the State of Nevada, did
18 drive on Spanish Trail Lane and West Tropicana, Las Vegas, Clark County, Nevada, and
19 wilfully and unlawfully fail to continuously provide security as proof of financial
20 responsibility for payment of tort liabilities arising from maintenance or use of said motor
21 vehicle by a contract of insurance for a motor vehicle liability policy, or by qualifying as a
22 self insurer, pursuant to Nevada Revised Statute, Chapter 485.

23 All of which is contrary to the form, force and effect of Statutes in such cases made
24 and provided and against the peace and dignity of the State of Nevada. Said Complainant
25 makes this declaration subject to the penalty of perjury.
