PROPERTY

REPORT NARRATIVE

**ORIGIN:**

On 10-17-10, at approximately 2210 hours, Officer Sims, Officer Hendrix and I responded to a radio call to contact reporting party, [REDACTED], reference a possible domestic violence incident that had occurred on 10-12-10.

**OFFICER'S OBSERVATIONS AND ACTIONS:**

Upon our arrival we spoke with [REDACTED] (see her statement below). [REDACTED] was crying hysterically and said she was scared to death. While talking to her I detected the odor of an alcoholic beverage emitting from [REDACTED]'s person. [REDACTED] told me she had been involved in a verbal and physical altercation with her live in boyfriend of one year, Junior Seau. [REDACTED] said on 10-12-10 Seau grabbed her hand with such force during an argument it caused her hand to swell and bruise. [REDACTED] said she did not tell officers on 10-12-10 this information because she wanted to protect Seau (see case number 10015506 for details).

[REDACTED] told me she and Seau were involved in another domestic violence incident tonight (10-17-10) were Seau grabbed her by her arm and shoved her into the wall/dresser in their bedroom. She said she sustained injuries as a result of the shove and knocked over a fish bowl that shattered. [REDACTED] Complained of pain to her head and right hand/arm. I observed [REDACTED] had a small red abrasion on her right forearm, and I felt a raised bump on the right side of her head. When I touched it she flinched and pulled away in discomfort. I observed a broken fish bowl on the floor of the bedroom. [REDACTED] shirt was ripped in the front. [REDACTED] showed me the fish that had been in the bowl. It was now in a smaller bowl on the kitchen counter. I observed dark bruising on her right hand. [REDACTED] said this was a result of the incident on 10-12-10 in Solana Beach. I wrote a courtesy report reference this incident to be forwarded to SDSO (see case number 10015506).

[REDACTED] also said her back was hurting. I noticed an abrasion on the upper left side of her back. FET Faaiu responded and took photographs of [REDACTED] injuries (see his report for details). I gave [REDACTED] an OPD Domestic Violence Pamphlet with this case number. Based on [REDACTED] statement, her relationship with Seau, and the presence of visible injuries it appeared that Seau had committed a violation of PC 273.5(a)-Domestic Violence. I asked [REDACTED] if she wanted me to get an EPO against Seau; she declined the offer.

While on scene Seau called [REDACTED] cell phone. I answered the phone with [REDACTED] permission and spoke with Seau. Seau told me he had been involved in a verbal argument only with [REDACTED] over relationship issues. Seau said [REDACTED] did not physically harm him in any way and he did not physically assault her in any way. He said they were only involved in a verbal argument. Part way through the conversation a digital recorder was placed up to the cell phone to record the conversation. Seau initially declined to respond to the scene to discuss the incident. He then asked if we would stand by at his

residence so he could retrieve some personal items. I advised Seau we would wait for him to return. Officer Sims, Officer Trabelsi and I along with Sergeant Stahley waited for Seau.

Seau arrived shortly after in a blue sedan with his friend, [REDACTED] driving. Seau exited the vehicle and I advised him he was being placed under arrest for a violation of PC 273.5(a)-Domestic Violence. Seau was placed in handcuffs without incident. I detected the odor of an alcoholic beverage emitting from his person and noticed his eyes were blood shot and watery. I then spoke with [REDACTED] (see her statement below). I transported Seau to the Oceanside Police Department (OPD) for further processing.
