I, Larry Wesley Hart, am a sworn Detective Sergeant with the Moore County Sheriff's Office and have been an officer in law enforcement since 1989; I have worked in various positions in my law enforcement career. I worked for the Vass Police Department for eight years and the first three years I worked as an patrol officer and the and the last five I was a Lieutenant responsible for supervising patrol officers, criminal and narcotics investigations. I was also sworn in 1989 as an auxiliary ABC Officer for the Moore County ABC Law Enforcement Division. I worked in an undercover capacity with confidential informants for approximately six months purchasing controlled substance from street level drug dealers. During your applicants 22 years of service as a law enforcement officer he has worked with many informants, in an undercover capacity purchasing narcotics and alcohol, and with other law enforcement agencies involving narcotics and alcohol investigations and violations. Your applicant has been involved in more than 1,500 violations of the North Carolina Controlled Substance Act and numerous violations of the North Carolina Alcohol Beverage Control Laws that led to arrest and conviction


