NARRATIVE

On 6/4/13 I responded to in reference to a dispute between neighbors. Upon arrival I met with Joshua Morse who advised he had returned home from work and heard a noise at his front door like a piece of paper being dropped near the door. Joshua Morse stated he went to the door and located a piece of paper with an insulting note written on it. The note was from his upstairs neighbors, Bobbi Kristina Brown and Nicholas Gordon, whom he has had issues with in the past. Joshua Morse advised that both subjects were in the process of moving out and had been making a lot of noise. He stated that there was an issue earlier with their dog in which another neighbor had complained. Joshua Morse also advised that someone had left notes on Bobbi Kristina Brown's door, apartment and that there had been some damage to the door as well. Joshua Morse advised that he had not complained about the couple's dog or leave any notes on their door. Joshua Morse stated he wanted the incident documented due to the ongoing issues he has been having with the couple.

Joshua Morse showed me the note which stated:

"Thanks. You are shit at the bottom of our shoe. Thank you for making a hard year harder. You are a miserable couple, and always will be. You were honored to have us living above you and you couldn't stand such a young beautiful couple being far more successful than you ever will be. I pray your misery doesn't rub off on your innocent little baby."

I attempted to make contact with either Bobbi Kristina Brown or Nicholas Gordon, however neither was home. I was advised by a subject cleaning the apartment that the two were in the process of moving out, had left the apartment, and would not be returning.
