AND THE GRAND JURY AFORESAID, by this indictment, further accuses the defendant of the crime of ENDANGERING THE WELFARE OF A CHILD (Sec. 260.10 (l) Penal Law), committed as follows:

The defendant, in the County of Rockland, in the State of New York, on or about the 6th day of May, 2010, knowingly acted in a manner likely to be injurious to the physical, mental, and moral welfare of "C.F.", a female child less than 17 years old.

FOURTH COUNT:
