**RE: CEASE AND DESIST FROM INVASION OF HARRASSMENT, INVASION OF
PRIVACY AND CYBERBULLYING**

Dear Ms. McFarland:

This **CEASE AND DESIST ORDER** is to inform you that your persistent actions including but not limited to releasing of a video allegedly concerning Willie J. Maxwell, II p/k/a "Fetty Wap" have become unbearable and are having a negative financial, personal and professional impact on Mr. Maxwell. You are **ORDERED TO STOP** such activities immediately as they are being done in violation of the law.

Mr. Maxwell has the right to his privacy and to remain free from your conduct as it constitutes harassment, an invasion of privacy and Cyberbullying. Please be advised that we will pursue any legal remedies available if these activities persist. These remedies include but are not limited to: contacting law enforcement to obtain criminal sanctions against you, suing you civilly for damages that Mr. Maxwell has incurred to his personal and professional reputation and for expectation damages that may occur as a result of tarnished business relationships.

Again, you must **IMMEDIATELY STOP** the distribution and/or the attempted distribution of this alleged video to any and all media outlets including social media platforms and send me written confirmation that you will stop such activities. A failure to do so will result in immediate legal action.

This letter shall act as your final warning to discontinue this unwanted conduct before we pursue legal actions against you. We are in the process of preparing a civil complaint in Federal Court

but we hope we can resolve this matter amicably without involvement of the legal system. Notwithstanding same, if you continue with your harassing conduct then this order acts as **ONE FINAL CHANCE** for you to discontinue your illegal activities before we take legal action.

To ensure compliance with this letter, and to halt any legal action we may take please have your attorney contact our office within one (1) day of receipt of this letter. Failure to do so will act as evidence of your infringement upon Mr. Maxwell's legal rights. Please be guided accordingly.
