Re: Notice to Cease and Desist Internet Defamation

Dear Ms. Latasha Kebe and Attorney Izmayloza,

Please be advised that our firm has been retained by Timothy and Jonjelyn Savage to investigate and take legal action against you for the series of unwarranted and defamatory attacks against them. Specifically, on your social media channels UNWINE WITH TASHA K on Youtube, Twitter, and Instagram, you have made several legally actionable defamatory statements about my clients.

I am writing to you directly on behalf of my clients, Timothy and Jonjelyn Savage, to officially demand to cease and desist the publication of defamatory statements, images, and social media post regarding my clients. We are formally demanding that Tasha K aka Latasha Kebe cease all such action immediately.

Under OCGA 51-5-4, Slander is defined as imputing to another a crime punishable by law; or uttering any disparaging words productive of special damage which flows naturally therefrom. Over the course of the week of November 25, 2019, Ms. Kebe has made utterly false statements about Timothy and Jonjelyn Savage that she knows or should have known were false. Examples included but are not limited to:

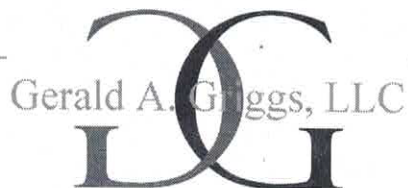
- allegations of drug abuse,
- allegations of creating a social media account to profit off of Joycelyn Savage's likeness and images,
- allegations of possession of a black box full of audio recordings.
- releasing clips of edited recorded statements.
- alleging that the Savages appeared on Good Morning America in New York, New York.

The above statements made in reference to the Savages are utterly false and without merit, and they are defamation per se in that they depict our clients as engaging in fraudulent activity that violates civil and criminal law.

Should you fail to cease this behavior, legal action will be immediately taken against you. We hereby demand the following:

1. Immediately remove from all social media accounts all defamatory and disparaging information regarding our clients made by you and your followers.
2. Immediately cease and desist in publishing defamatory statements about our clients whether the statements are made by you or third parties.
3. Compensate our client for its attorney's fees and costs.
