I went to the party at 213 1st  
AND Bronxwood Ave about 11:30 P.M. with  
Tyrone Brown, TARIK, WINSTON Phillips.  
Winston drove a dark red Acura Integra,  
new model, and we were with him. While  
at the party we came in contact with  
kids from the Valley. They started  
gathering and talking about us. They  
looked like they were ready to start  
trouble with us. We left right away  
and proceeded to the car. About 25  
kids were running behind us. We turned  
around and started to fight with them.  
More came and we ran to the car  
and drove off. We went back to  
Section 5 - Coop City and got a rifle.  
I got the rifle from the storage  
room in my building on the 20th floor.

TYRONE AND TARIK CAME BACK AND WE GOT INTO THE SAME ACURA AND WENT BACK TO THE PARTY. IT WAS ABOUT 1 OR 1:30 AM WHEN WE GOT THERE. WE DROPPED OFF TARIK AT THE CORNER OF BARNES AND 213TH ST. HE WALKED UP THE BLOCK, HE HAD A RAZOR. WE DROVE BEHIND HIM, WINSTON WAS DRIVING, I WAS IN THE REAR PASSENGER SIDE, TYRONE WAS IN THE BACK DRIVERS SIDE. TARIK GOT NEAR THE PARTY AND THE VALLEY PEOPLE STARTED A RUCKUS WITH HIM. WE THEN SPED UP AND HE AND TYRONE JUMPED OUT OF THE CAR. TYRONE HAD A RAZOR AND HE AND TARIK STARTED FIGHTING WITH A GROUP OF THEM. THEN TARIK AND TYRONE STARTED RUNNING BACK TO THE CAR, PEOPLE WERE CHASING THEM, I SAW PEOPLE GOING FOR GUNS AND SHOTS RANG AND HIT THE CAR (ACURA). I THEN WENT INTO THE TRUNK WHICH WAS OPEN AND TOOK OUT THE RIFLE. I SHOT THE RIFLE INTO THE VALLEY CROWD IN THE LOT. I AIMED AT SOMEONE WITH A HAND GUN, HE WAS FIRING IT. I THINK HE'S THE ONE THAT HIT THE ACURA. I FIRED ABOUT 12 TIMES. THREE OR FOUR AT HIM AND THE REST AT THE CROWD.

AND FIRED TWO SHOTS AT HIM. MY GUN  
IS A .22 CAL LONG RIFLE. I LOADED IT  
WITH 15 .22 CAL BULLETS ALL TOGETHER.  
WE THEN DROVE TO MY BUILDING, WINSTON  
DROPPED US OFF AND TARIK, TYLONE, AND  
ME WENT HOME. IT WAS ABOUT 2: AM.  
THE NEXT AFTERNOON, THIS AFTERNOON 8-4-91  
ABOUT 3 PM WE HEARD THAT SOMEONE CALLED  
BOX WAS KILLED AT THE PARTY. I DIDN'T  
DWELL ON IT BECAUSE I DIDN'T THINK  
IT WAS US.

WHEN I ARRIVED AT THE 4TH ACT  
I TOLD DET MALANDRO WHERE THE GUN WAS  
AT AND WENT WITH HIM AND SHOWED HIM  
WHERE IT WAS. I WANTED THE POLICE TO  
HAVE THE GUN BECAUSE I DON'T BELIEVE  
THIS WAS THE GUN THAT KILLED BOX.

I WISH TO MAKE THIS STATEMENT ON  
MY FREE WILL. I WAS ADVISED BY DET  
MALANDRO OF MY RIGHTS, WHICH I UNDERSTAND.
