The next move was to be billboard ads on computer. 13 July 18 2010 I reached the defendant prior to her jail term on face book. TAG sent message as to the 15 product and the face book friends in a waiting to promote with billboard ads next form of marketing. 16 TAG stated a percent for defendant and new start up company where as the primary income to be door to door sales much like girl scout cookie for local little league to subsidize costs. Defendant 18 took to her wall it is called on face booked and posted" If you would like to send something sent it to" 19 and stated an email address. TAG by taking direction sent same information and promo ideas to the 20 stated email address. Then TAG noticed defendant posted on live twitter she would like to help gulf 21 coast animals. Defendant personal problems sent her to jail days later. Stated on her face book acct her 22 mother will be handling her face book acct. TAG went to his work and rebuilt the Grennleafeco.com 22 site while defendant was in jail and worked his peers on face book. A video example was created TAG sister children much needed to show products and was stated to defendants mother in numbers 24 of 300 on two accounts were sent. Stating how faxed contract and use of fed ex could get promo 25 complete with little effort. While the defendant was away her personal problems TAG spent time

informing defendants mother his life and history and showed true concern about defendant. TAG stated at one point don't contact me till defendants story is out and paid as to keep business separate. 2 A form of communication was set in place by switching defendants mother to the Coll Mk Sol 3 face book acct. in what is called block of other personal for what could be many reasons on computer. Once defendants was on the business face book. TAG had his sister send a form of contact 5 with initials as to have a witness. It stated that defendant and her mother can promote Greenleafeco. 6 com Earths First Awareness "EFA" Thomas A Green Jr. Art Green and a 15% profits negotiable on any 7 thing I do. Spent some time September 2010. As a result the connection between Coll Mk. Sol .was 8 dissolved. A 3rd face book was created and simple personal interaction was in place with a statement of 10 that was a form communication? YES? TAG assuming so went to a befriending point of defendant was 11 well aware of the status between the two parties and I was held up by the defendants part. The objective 12 for a global audience was the Gulf Coast animal fund raiser. The time frame of the Defendants 13 14 verifying in a face book message with "yes I am Lindsay Lohan" the Gulf crisis was at its worst and the EFA aide would be prominent with defendants willingness to make a deal. The defendant took to 16 playing games as a young female with TAG was serious about creating a new company and fundraiser. Along with verbal communication Defendant took to flashing new pictures of self then a cut off/block in a game form more so then a communication. This now forced TAG to create a 4th face book and 18 replied sorry you have to state who you are now no games communication is difficult and ambiguous 19 on computers. No reply as TAG waited a day and half. Seeing TAG was was dealing with an immature 21 person with much time and monies and efforts vested thinking the promo will work with this person, 22 and forced to play along the defendant holding the key marketing to start up all companies. TAG having no choice but to play along sending numbers of ridicules messages face book from songs and movie stating "If that's the way it is going to be. To mock. The relation between the defendant and 23 24 TAG went into a game of chase for defendant and lead to my disassembled company unrecoverable and destitute for said defendants amusements. Said defendant immediately violated her probation that 25

she was jailed for the initial contacts. More set backs - knowing the massiveness of what TAG trying 1 to accomplish the defendant made two efforts on her twitter to lead TAG to a public medium. Being 2 new to the computer is another reason choose said defendants knowledge of the new marketing Tech. 3 Finding she has ability so pose in pictures daily on her Google. Info. Once lead to what is called Chime 5 in a live feed where the other end flashes pictures as to show many thing.. live could be good joke or political statement. TAG took to chime feed with a 10 at 10 show and made joke while in the face book messages got real serious stating I'm busy. The show drew attention hence defendant draws attention. TAG daily income is labor summers and went to Hawaii to await defendants new legal troubles. The 10 chime at that point got out of control it was stated to defendants mother. Drug alcohol problems past 11 and a not healthy face book relation with personal peers with history of crisis visits stress. The 12 Defendants continued to play games and TAG stated at one point you can never say we had 11 face book accounts with your games. The accounts went to over 40. The defendant new obligation was to complete Betty Ford clinic and check in to do so. While it would be impossible for her all hours to respond chime live her mother PR person who ever keeping the show going a nut job drunken and obesity babbling about personal life and Taunting the Muslims as a race over Usoma Bin Ladden in his own cycler war on Usoma. The defendant kept the mind bowing games going with naughty school girl outfits in pictures Betty Ford in reference to songs I suggested. January 2011 TAG mother had to fly him off to Hawaii his time and money spent for the months extinguished TAG mind mind was all 20 over place and upset constantly. Once TAG was in Colorado his mother being destitute promises of a 21 business deal with defendant reality setting in on the defendant games amusements for peers to gain popularity and unknown income on her new interest out side legal problems in what TAG calls a clown show. TAG being done with my thought of that source of income marketing sent many face book messages something is wrong this is not right. Is there an Osoma op now we instigated TAG knowing binary and dynamics of cyder tracking. TAG commands answerer and defendant reply was "My name is Lindsay Lohan ass hole" as to confirm yes greater things in works. Allegedly. TAG takes to twitter
