

**Affidavit in Support of Search Warrant
County of Los Angeles**

Your affiant, Detective Ginni Alvarez, is employed as a full-time, sworn law enforcement officer for the Los Angeles County Sheriff's Department and has been for the past 9 years. During your affiant's tenure, your affiant has assisted in investigating numerous cases involving identity theft, fraud, forgery, vandalism, assault, and burglary.

Your affiant is currently assigned as a Detective for Malibu/ Lost Hills Sheriff's Station, Detective Bureau.

On 01/10/14, I was assigned to investigate Los Angeles County Sheriff's Department Vandalism and Non-Aggravated Assault Incident Report # [REDACTED]. The victim, Jeffrey Schwartz, alleges the suspect, Justin Bieber, threw raw eggs at his residence causing significant damage. See report, herein and incorporated as Exhibit #1.

On 01/14/14, I issued a search warrant at the residence of Suspect Bieber. During my search warrant, I was able to review from Suspect Bieber's surveillance system, footage corresponding to the date and time this incident occurred. Upon my review, I observed a male white, who resembled and who I will refer to as Suspect Bieber, run from the direction of Victim Schwartz' residence and up the driveway at Suspect Bieber's residence and out of view. Suspect Bieber appeared to enter his residence momentarily. Several other males emerged from Suspect Bieber's garage door and a black SUV which backed into Suspect Bieber's driveway.

I observed Suspect Bieber run back down his driveway from his residence and in the direction of Victim Schwartz' residence. Several males followed Suspect Bieber in the same direction. I then observed these same males run back to Suspect Bieber's residence, some appearing as if they were hiding behind the vehicles in the driveway while trying to maintain a view in the direction of Victim Schwartz' residence.

A short time later, I observed Suspect Bieber run back to his residence and up his driveway. He was approached by the group of males, some of whom Suspect Bieber is observed "high fiving". Suspect Bieber and the other males appeared to be laughing and celebrating.

After I reviewed the video, I contacted Victim Schwartz by telephone and asked if he could provide in more detail, the attire Suspect Bieber was wearing during the incident. Victim Schwartz stated his daughter, Victim Jessica, observed Suspect Bieber wearing the same attire in an Instagram photo Suspect Bieber posted on the same day (January 9, 2014) this incident occurred. Victim Schwartz captured the Instagram image on his phone and emailed it to me.

I compared Suspect Bieber's attire in the Instagram photo to the attire Suspect Bieber was wearing in the surveillance video. I observed Suspect Bieber was in the same attire as accounted by Victim Jessica and depicted in the Instagram photo. Suspect Bieber is wearing a white sweatshirt with black images along the neckline. Suspect Bieber is also wearing a dark colored ball cap with a white logo in the center. See copy of the Instagram photo and comparison to photo still from surveillance footage, herein and incorporated as Exhibit #2.



Affiant further requests that Instagram be ordered not to notify any person (including the subscriber or customer to which the materials relate) of the existence of this order for 90 days. Affiant submits that such an order is justified because notification of the existence of this order could seriously jeopardize the ongoing investigation. Such a disclosure could give the subscriber an opportunity to destroy evidence, notify confederates, or flee or continue his flight from prosecution.


