



When victim-ofc. attempted to restrain def once def was on the ground, def grabbed victim in the crotch and squeezed. Victim declined to be examined and told medical personnel he had no injuries except soreness. Def has no criminal record. Based on absence of injury and def's absence of criminal history, case is referred to C.A. for misd. consideration.
