Comments Victim stated that she went to the Marriot to meet with a man she had met earlier that evening and exchanged phone messages and numbers. She went into his room for about 1/2 hour and he then asked her to leave because of a curfew issue. She then met suspect Mondy in the hallway and he invited her into his room and she accepted. Once inside his hotel room she met suspect Williams. Suspect Williams left the room after a short while and suspect Mondy had sexual intercourse with her and she told him that she was not comfortable with him doing that. She stated that she told him several times to stop but he ignored that and continued. She stated that suspect Williams then came back into the room and suspect Mondy left the room. She stated that she told suspect Williams that Mondy had been aggressive toward her and that she didn't like his aggressiveness. She then consensually engaged in sexual intercourse with suspect Williams. She stated that Suspect Mondy then came back into the room and asked if he could get in bed with her and suspect Williams. They both said yes he could and got in bed with them. Mondy then had sex with her again. Then Mondy went back into his own bed and she got into his bed and they had sex again. They asked her to leave multiple times as they had a curfew and a coach that would be checking their rooms. Eventually she left and as she was driving away past the parking attendant she was feeling bad and crying and the attendant asked if she was all right and she told him she thought she might have been raped. He advised her to report it and she returned to the hotel and reported. Both suspects were interviewed and denied that she ever said stop or indicated in any way that she did not want to engage in sex with either of them. The victim stated that suspect Williams did not force her in any way and that the sex with him was completely consensual. Suspect Williams's statement corroborated suspect Mondy's statement regarding all events to which he was a witness. Unable to prove BRD as to either suspect.
