1. Plaintiff KRISTEN COLEMAN is, and at all times mentioned herein was, a resident of Los Angeles County, California.

2. Defendant JOSEPH KEYSHAWN JOHNSON (hereinafter "Defendant Johnson") is, and at all times mentioned herein was, a resident of Los Angeles County, California.

3. On or around August 13, 2010, in Los Angeles, California, Plaintiff and Defendant Johnson entered into a written Settlement Agreement (hereinafter referred to as "Agreement")

4. The Agreement provides in paragraph 1(a) that Defendant shall pay to Plaintiff the sum of \$125,000.00 in full and final settlement of Plaintiff's alleged legal claims against Defendant. The Agreement provides that the settlement monies shall be paid to Plaintiff in monthly installment payments commencing August 16, 2010, with the final payment due on January 1, 2011. The Agreement further provides in paragraph 1(a) as follows: "If any of the

1 afore-referenced payments are more than ten days late, the entire balance shall become due and  
2 payable.”

3 6. Defendant was approximately 30 days delinquent in tendering the first installment  
4 payment of \$25,000.00 to Plaintiff. In accordance with the Agreement said payment was due on  
5 August 16, 2010 and Defendant did not tender payment until September 14, 2010. A true and  
6 correct copy of the first installment payment is attached hereto as Exhibit “A”. In spite of  
7 Defendant’s breach of his obligation to pay Plaintiff on August 16, 2010, she did not instigate  
8 litigation pursuant to the Agreement.

9 7. The second installment payment in the amount of \$20,000.00 was due and owing  
10 from Defendant to Plaintiff on September 1, 2010. As of October 5, 2010, the second installment  
11 payment has still not been tendered to Plaintiff. The second installment payment is more than ten  
12 days late, and according to the Agreement, because Defendant has breached the Agreement the  
13 entire outstanding balance of \$100,000.00 is immediately due to Plaintiff. Plaintiff is also entitled  
14 to interest at the legal rate from September 1, 2010 to the present.

15 8. Plaintiff has fully complied with her obligations under the Agreement.

16 9. The Agreement further provides at paragraph 15 as follows:

17 “The parties agree that in the event litigation is initiated by any party  
18 to interpret or enforce this Agreement, the prevailing party will be  
19 entitled to recover legal costs and reasonable attorney fees incurred  
20 in conjunction with the litigation...”

21 WHEREFORE, Plaintiff prays for relief against Defendant as follows:

- 22 1. Damages in the amount of \$100,000.00 plus interest;  
23 2. Reasonable attorney fees and costs in accordance with the Agreement;  
24 3. Such other and further relief as this Court deems just and proper.


