We drove to 7265 Santa Monica Bl (Westlake Recording Studios) regarding a fight. Our investigation revealed Victim Breaux, a music artist also known as Frank Ocean, was battered by Suspects Brown, Omololu, and Glass due to an apparent argument over a parking space.

The victim was initially uncooperative and did not want to give any details of the fight at the location of the incident, except for saying that he was assaulted. The victim also refused any medical treatment for a cut to his right index finger and minor cut on his left temple. The victim went to Cedars Sinai Hospital on his own and agreed to talk to us once at the hospital. Therefore, no arrests were made at the time of this report.

Once at the hospital, the victim told us Suspect Brown, also a music artist, was parked in the victim's assigned parking spot at Westlake Recording Studios. He walked to Suspect Brown in the lobby of the Studio and told Suspect Brown that he was parked in his parking spot. Suspect Brown extended his hand to the victim, however, the victim refused to shake Suspect Brown's hand and reiterated that Suspect Brown was parked in his spot. Suddenly, Suspect Brown punched the victim on the side of his face. Thereafter, Suspects Omololu and Glass jumped in to help Suspect Brown beat the victim. The victim fought back to defend himself as all three suspects pushed him into a corner and attempted to kick him while on the ground. The entire fight lasted 1 to 2 minutes. The victim believes he might have heard someone yell, "faggot!" but was unsure who, if anyone, made the statement. After the beating, Suspect Brown said, "We can bust on you too! "Bust" is a slang term used on the street to mean shoot. The three suspects left the studio in an unknown direction.

We spoke to Witness Uzowuro and he told us the following: He saw the whole fight. Suspect Brown was parked in the victim's parking space. The victim confronted Suspect Brown about parking in his space. When Suspect Brown attempted to shake the victim's hand, the victim refused and was immediately punched by Suspect Brown. Suspects Omololu and Glass jumped in to help Suspect Brown beat the victim. After the fight, the suspects left the Studio in an unknown direction. Witness Uzowuro called the Sheriffs and waited for our arrival.

We spoke to Witness Brownlie ~~XXXXXXXXXXXXXXXXXXXX~~ and he told us the following: He was present during the altercation between the victim and Suspect Brown from beginning to the end. He said the victim and Suspect Brown were arguing over a parking spot. During the argument, Suspect Brown punched the victim in the face. The fight between the victim and Suspect Brown lasted for approximately 2 minutes.

Since there were numerous people there, he does not remember if others were involved in the fight or trying to stop it. After the fight, Suspect Brown and Brown's friends (NFD) left the Studio.

We spoke to Witness Wilson and he told us the following: He was in the lobby when the fight started but does not know who threw the first punch. He does not remember how the fight started and only remembers seeing 6 people involved in a fight, NFD.

We spoke to Suspect Glass. Deputy McLeod #476223 assisted in initially detaining Suspect Glass pending the fight investigation. Suspect Glass only answered a few questions and said he was only involved in the fight to the extent that he was trying to stop it.

We spoke to Suspect Omololu and he told us the following: The victim and his friend (believed to be Suspect Brown) got into a fight over a parking spot. He does not know who started the fight, but he joined in the fight when he saw his friend get punched. Suspect Omololu does not know who he punched, but said it was to defend his friend.

Deputy Servin #503737 interviewed Witnesses Balaguer and McAulay [REDACTED]. In Deputy Servin's supplemental report, Witnesses Balaguer and McAulay said they saw the victim and Suspect Brown fighting in the lobby area over a parking spot. Neither witness knows who threw the first punch. After the fight, Suspect Brown and two of his friends (NFD) left the studio. See Deputy Servin's supplemental report under the same file number for further.

Based on the above statements, we determined the victim was initially battered by Suspect Brown due to an argument over a parking spot. Two of Suspect Brown's friends (believed to be Suspects Glass and Omololu) jumped in to help Suspect Brown beat the victim. Since the victim was not initially cooperative and non-desirous of a report during our investigation, we were unable to make any arrests. Once we were able to talk to the victim, in private, at Cedar Sinai hospital, he told us he was desirous of prosecution.
