N A R R A T I V E

ON 05/03/10 MARK HATTEN REPORTED TO OFFICER WHITE THAT HE RECEIVED WHAT HE BELIEVE TO BE A THREATEN EMAIL ON MYSFACE. MR.HATTEN STATED THAT ABOUT 4:12AM ON 05/03/10 HOWARD K. STERN SENT HIM A MESSAGE. THE MESSAGE STATED. " YOU ARE IN OVER YOUR HEAD. YOU ARE BEING WATCHED. KEEP A LOOK OUT BEFORE EVERYTHING COMES CRASHING DOWN, DO YOU UNDERSTAND ME?"

MR.HATTEN STATED THAT HOWARD STERN IS IN CALIFORNIA AND HE IS HERE IN SOUTH CAROLINA, HE IS NOT AFRAID, BUT BECAUSE HE IS A WITNESS IN A CASE AGAINST MR.STERN HE DOES TAKE THIS TO BE A THREAT. MR.HATTEN STATED THAT HE WAS ADVISED BY ATTORNEY RENEE ROSE TO FILE A REPORT WITH THE LOCAL LAW ENFORCEMENT. MR.HATTEN WAS ABLE TO PULL THE MESSAGE UP ON THIS OFFICER'S LAPTOP TO SHOW EXACTLY WHAT WAS SENT TO HIM. THIS OFFICER PRINTED THE MESSAGE PAGE AS WELL AS COPIED THE MESSAGE AND PRINTED JUST THE MESSAGE. THE MESSAGE WAS SENT TO MARK HOLLYWOOD HATTEN THE NAME THAT IS ON MR.HATTEN'S SITE.

OFFICER WHITE WAS GIVEN THE NAME, TELEPHONE NUMBER AND THE FAX NUMBER TO SEND A COPY OF THE REPORT TO MS.ROSE. OFFICER WHITE ATTEMPTED CONTACT WITH MS.ROSE TO OBTAIN INFORMATION ON MR.STERN AND WHAT WAS GOING ON WITH THE TWO MEN. OFFICER WHITE WAS INFORMED THAT ANYONE THAT IS A POTENTIAL WITNESS OR IS WRITING A BOOK ABOUT ANNA NICOLE SMITH IN SOME FORM IS GETTING EMAIL OR SOMETHING FROM MR.STERN. OFFICER WHITE WAS INFORMED THAT BOTH MEN WERE IN ANNA NICOLE SMITH'S LIFE IN SOME CAPACITY AND THEY CLASH. MR.STERN WAS MS.SMITH'S LAWYER, BEST FRIEND, WHATEVER SHE NEEDED HIM TO BE AND HE HAS ATTEMPTED OR IS SUING ANOTHER AUTHOR IN NEW YORK FOR HIS BOOK ABOUT MS SMITH.

OFFICER WHITE ADVISED MR.HATTEN TO LET OFFICERS KNOW IF THE MESSAGES CONTINUE. OFFICER WHITE ADVISED MS.ROSE THAT SHE WOULD FAX HER A COPY OF THE REPORT.
