REPORT OF POSTMORTEM EXAMINATION

I. History that the decedent was found face down in the water at Horn Island.

II. Subcutaneous scalp contusions, bilateral superior nuchal line area.

III. No other external or internal injuries.

IV. No internal organ abnormalities contributing to death.

V. Toxicology (chest decomposition fluid):

A. Ethanol 270 mg/dL.

B. Cannabinoids presumptive positive *.

C. Nicotine and cotinine presumptive positive.

D. Caffeine presumptive positive.

* Comment: Confirmatory testing did not reveal cannabinoids in the decomposition fluid.

Postmortem Radiographs:	X-rays of the head and neck reveal no visible injuries of the skull or cervical spine. X-rays of the hyoid bone show unfused greater horns without fractures.

EVIDENCE OF INJURY

Two dark red-purple subcutaneous scalp contusions overlie the superior nuchal line area of the posterior skull. Each measures approximately 2 inches. There are no external scalp injuries. No fractures are in the skull. No hemorrhages overlie the brain. No hemorrhages are within the partially liquified brain parenchyma.

INTERNAL EXAMINATION

Brain: 1,342 grams Markedly softened and partially liquified.

Neck: The larynx and hyoid bone are without hemorrhages or fractures. The anterior cervical spine is unremarkable.

Left: 353 grams No fluid or debris is within the airways.

GI Tract: Unremarkable. The stomach is empty.

Liver: 835 grams

Spleen: 92 grams

Body Cavities: Each chest cavity contains approximately 100 mL of red-brown decomposition fluid.

The internal organs (unless otherwise specified) are free of injury and significant natural disease or pathologic change.

SUMMARY AND INTERPRETATION

This 18 year old male was found face down in the water at Horn Island. Because the circumstances surrounding this death are unknown, the cause and manner of death are best classified as undetermined.

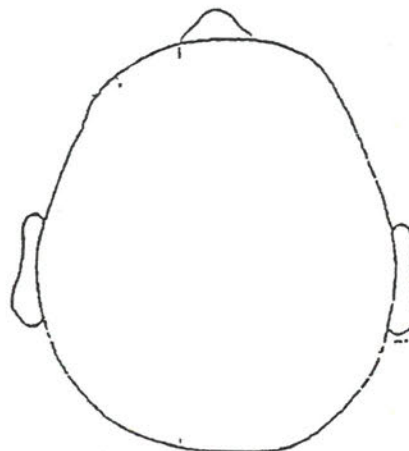
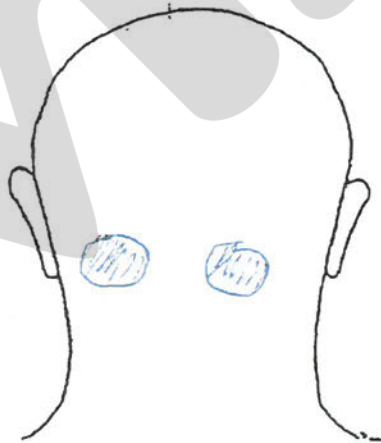
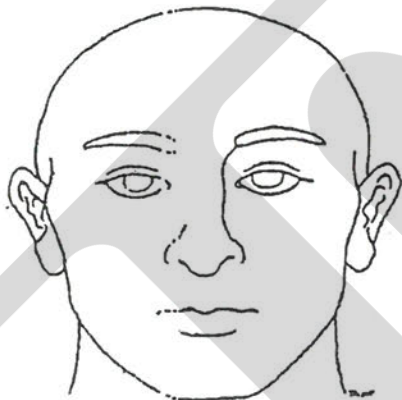
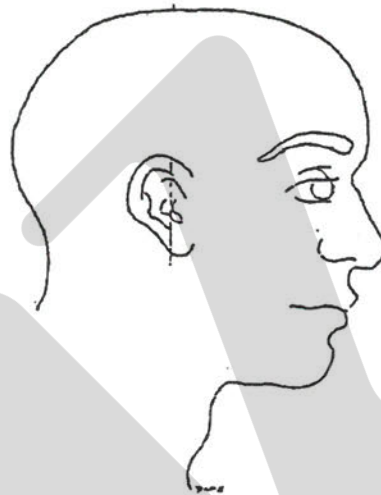
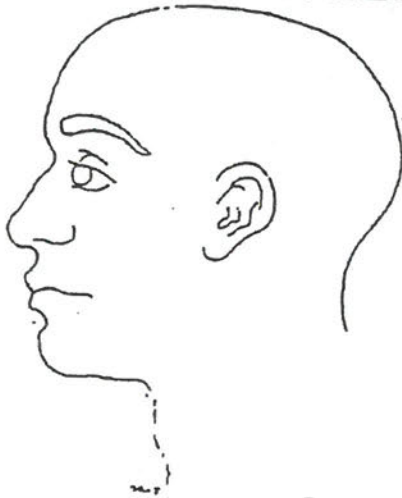
