WAS DISPATCHED TO IN REFERENCE TO A PRIOR  
UPON MY ARRIVAL I MADE CONTACT WITH MARIAH YEATER (DOB 09/05/81)  
AND STATED THAT MARIAH HAD RETURNED  
TO THE RESIDENCE TO ATTEMPT TO WORK OUT A PAYMENT PLAN AFTER BREAKING LACY-  
INN'S CAR WINDOW. DURING THE CONVERSATION, MARIAH BECAME ENRAGED AND BEGAN  
D SCREAM AT HU, IS MARIAH'S EXBOYFRIEND.  
THE ALTERCATION BETWEEN MARIAH AND ESCALATED TO THE POINT THAT MARIAH  
SLAPPED 3 SEPARATE TIMES WITH HER OPEN RIGHT HAND. AT THAT TIME  
STEPPED IN TO ATTEMPT TO PREVENT ANY FURTHER BATTERY. THIS INCIDENT WAS  
ALSO WITNESSED BY  
BASED ON THE FACT THAT MARIAH DID SLAP HER EXBOYFRIEND 3 TIMES IN THE
