back in - he then started asking me a ~~bunch~~
bunch of questions (personal) and I told him
it was none of his concern. I had some flowers
on my kitchen table a friend had sent me,
and he started on them, I told him "at least I
didn't have to pay for them myself" and he said
"no, but you f--- him". I told him to
leave Ed he called me a whore - so I slapped
him^c my right hand across his right cheek Ed
he turned his head Ed said "hit me again" - I
said "no, I don't want to hit you again, I just
want ~~you~~ you to get out of my house." He said
"make me" ^{he pushed me with his hands on my shoulders} I went to the phone to call the
police - he grabbed the phone out of my hand
and jerked it out of the wall. Finally he
went to the door - still calling me a whore
the whole time - he was at the front door
Ed wouldn't go on out Ed I was trying to
push him out the door Ed I slapped him
again - telling him to "get out, just get out"
Finally he went out - I guess he went to
his car, I was getting the phone fixed when
he came back in Ed he asked if I was going

out of my house now!" When he left he said
"I see you in jail" Ed I said "no, in jail
