

1 **ATTACHMENT A IN SUPPORT OF REQUEST FOR RESTRAINING ORDER**
2 **AGAINST DENNIS SHAUN BOWMAN**

3 **I. INTRODUCTION**

4 Kimberly Kardashian is a well-known actress, model, and television personality. She is
5 being stalked and harassed by respondent Dennis Shaun Bowman, a delusional individual who
6 believes that he is in a romantic relationship with Kardashian. Kardashian does not know
7 Bowman and does not desire any contact with him. Bowman has been told by the Los Angeles
8 Police Department, Threat Management Unit, that Kardashian does not want any contact with him
9 and to stop attempting to contact her. Despite the order from the LAPD, Bowman has persisted in
10 contacting Kardashian. Bowman has also been sent a cease and desist letter by Kardashian's
11 attorneys but he continues to contact her. Kardashian is extremely frightened by Bowman because
12 he is obsessed with her and is extremely delusional. The LAPD had advised Kardashian to obtain
13 a restraining order because they believe that Bowman potentially poses a threat. Accordingly, an
14 immediate temporary restraining order should be issued against Bowman. This request is
15 supported by the attached declarations of Kimberly Kardashian, Detective John Gregozek, and
16 Jeremiah Reynolds.

17 **II. FACTUAL SUMMARY**

18 A. Bowman has Been Harassing and Stalking Kardashian

19 Beginning in or around late-September 2009, Kardashian began receiving messages from
20 Bowman via her Twitter account. (Declaration of Kimberly Kardashian attached hereto
21 ("Kardashian Decl."), ¶ 3.) Kardashian had never met Bowman. (*See id.*) She does not know
22 who he is. (*See id.*) Bowman is apparently under the delusion that she was and is interested in
23 some sort of romantic relationship with him. (*See id.*) Bowman would send her numerous
24 messages each day telling her, for example, that they are in love, that they will go to dinner
25 together, and that he is going to marry her. (*See id.*)

26 Beginning in September 2009, Bowman began to make numerous attempts to meet
27 Kardashian in person. (Kardashian Decl., ¶ 4.) For example, in late September 2009, Kardashian
28 made a promotional appearance at "Famous Cupcakes" in Beverly Hills, California. (*See id.*)

1 Bowman attempted to meet with her at the promotional appearance but arrived after Kardashian
2 had already left the location. (*See id.*) The staff of Famous Cupcakes informed her that Bowman
3 acted in an extremely bizarre manner and they were frightened by his actions. (*See id.*)
4 Kardashian was informed by the staff of Famous Cupcakes that Bowman returned on three
5 separate occasions looking for her and each time acted in a very bizarre manner. (*See id.*) On at
6 least one of those occasions, Bowman was in the face paint worn by the “Joker” in the Batman
7 comic books. (*See id.*) The staff informed her that Bowman acted in such a bizarre and hostile
8 manner when told that Kardashian was not at the location that they were forced to call the police
9 department. (*See id.*)

10 Sometime in October 2009, Bowman sent Kardashian a video of himself in “Joker” face
11 paint. (Kardashian Decl., ¶ 5.) He explained in the video that he had moved from Georgia to
12 Calabasas, California to attempt to make contact with her. (*See id.*) He said in the video that he
13 thought that Kardashian had traveled from Los Angeles to Atlanta, Georgia to have dinner with
14 him, but that he had arrived late at the restaurant and was under the delusion that he had stood her
15 up. (*See id.*) None of this was true and Bowman was clearly suffering from delusions. (*See id.*)
16 Bowman also said in the video that he had attempted to make contact with her at a night club in
17 Atlanta where Kardashian was making a promotional appearance, but that the size of the crowd
18 prevented him from contacting her. (*See id.*) He said in the video that they were in love and that
19 they should be together. (*See id.*) The video was extremely disturbing to Kardashian and caused
20 her to be extremely frightened and concerned for her safety. (*See id.*)

21 In October 2009, Kardashian made a promotional appearance at the Beverly Center mall in
22 Los Angeles, California. (Kardashian Decl., ¶ 6.) Kardashian was informed by security that Mr.
23 Bowman had attempted to make contact with her at the mall and that he was acting in an
24 extremely bizarre manner. (*See id.*) The security at the Beverly Center informed her that they
25 had ejected Mr. Bowman from the mall because they believed he presented a security threat to her.
26 (*See id.*)

27 In November 2009, Kardashian announced on her Twitter page that Kardashian had just
28 gotten a smoothie drink at the Body Factory in Santa Monica, California. (Kardashian Decl., ¶ 7.)

1 Kardashian was informed by the staff that Bowman had arrived at the Body Factory sometime
2 thereafter and demanded that he be allowed to see her. (*See id.*)

3 In November 2009, Kardashian made a promotional appearance at the Westfield Mall in
4 Culver City, California. (Kardashian Decl., ¶ 8.) Given Bowman's strange actions and his
5 numerous previous attempts to contact her, Kardashian had informed security at the mall to be
6 aware that Bowman might attempt to make contact with her. (*See id.*) Security at the mall
7 informed her that Mr. Bowman had arrived at the appearance and demanded to speak with her.
8 (*See id.*) However, he was not allowed to do so.

9 B. The LAPD Interviews Bowman and Tells Him to Stop Contacting Kardashian but
10 He Continues to Contact Her

11 Kardashian filed a police report with the Los Angeles Police Department following Mr.
12 Bowman's attempt to contact her at the Westfield Mall. (Kardashian Decl., ¶ 8.) On November
13 17, 2009, in response to the report filed by Kardashian, Detective John Gregozek, Serial No.
14 34087, along with Detective Hoffman, Serial No. 30708 of the LAPD's Threat Management Unit,
15 located and interviewed Bowman at a Laundromat where he lived and worked in the city of
16 Calabasas. (Declaration of Detective John Gregozek ("Gregozek Decl.") ¶ 2.) Bowman told the
17 Detectives that he moved from Georgia about 2 months ago to pursue a career in acting and
18 performing. (*See id.*) Prior to moving from Georgia, Bowman signed up for Twitter and was
19 automatically signed up as a follower to Kardashian. (*See id.*) Bowman later saw a posting on
20 Kardashian's Twitter page stating that she wanted to have "sweet dreams." (*See id.*) Bowman
21 videotaped himself singing a song to Kardashian and sent her the link in a Twitter message. (*See*
22 *id.*)

23 Sometime after Bowman sent the video, it was reported in the media that Kardashian had
24 broken up with her boyfriend, Reggie Bush. (Gregozek Decl. ¶ 3.) Bowman told the Detectives
25 that he believed Kardashian had broken up with Bush because of his song to her. (*See id.*)

26 Bowman informed the Detectives that Kardashian later made a promotional appearance at
27 a nightclub in Atlanta, Georgia, and Bowman stated that he thought that Kardashian was going to
28 Atlanta to have dinner with him. (Gregozek Decl. ¶ 4.) When Kardashian did not show up at the

1 restaurant where Bowman was, Bowman became concerned that he was at the wrong restaurant
2 and had stood-up Kardashian. (*See id.*) Bowman attempted to make contact with Kardashian at
3 the night club, but could not get close to her due to the size of the crowd. (*See id.*)

4 Bowman told the Detectives that he moved from Georgia to Calabasas, California because
5 he knew that Kardashian's family lived in Calabasas and hoped to see Kardashian around town.
6 (Gregozek Decl. ¶ 5.) Bowman admitted to the Detectives he made numerous attempts to contact
7 Kardashian, including at her family clothing store located in the city of Calabasas in September, at
8 Famous Cupcakes in North Hollywood in September, at the Beverly Center in October, and the
9 Westfield mall in Culver City in November. (*See id.*) Bowman told the Detectives he attempted
10 to contact Kardashian because she was not replying to his postings and he wanted to apologize to
11 her for missing their dinner date. (*See id.*) Bowman felt Kardashian was offended by him and that
12 he would not get work as an actor as long as she felt this way. (*See id.*)

13 The Detectives explained to Bowman that Kardashian did not know him or desire any
14 contact from him. (Gregozek Decl. ¶ 6.) The Detectives further explained to Bowman that his
15 messages and attempts to approach Kardashian in person caused her to be fearful for her safety.
16 (*See id.*) Bowman apologized for causing concern and stated he would not contact Kardashian
17 through Twitter or any other means. (*See id.*)

18 C. Bowman Refuses to Abide by a Cease and Desist Letter from Kardashian's
19 Attorneys and Sends Bizarre Emails in Response

20 Kardashian was informed by the Threat Management Unit of the LAPD that they had
21 interviewed Mr. Bowman on November 17, 2009 and had told Mr. Bowman that Kardashian did
22 not want to have any contact with him. (Kardashian Decl., ¶ 9.) Despite the order from the LAPD
23 to not contact her, Bowman continued to send her bizarre messages via her Twitter account
24 throughout December 2009 and January 2010. (*See id.*, Ex. A.)

25 On January 3, 2010, Kardashian instructed her attorneys to send Bowman a letter
26 demanding that he cease and desist contacting her through any means, including Twitter, email or
27 personal contact. (Kardashian Decl., ¶ 10.) On Monday, January 4, 2010, her attorneys emailed
28 Bowman to demand that he "cease and desist all further attempts to make contact with Kimberly

1 Kardashian.” (Declaration of Jeremiah Reynolds (“Reynolds Decl.”) ¶ 2, Ex. A.) Her attorneys
2 informed Bowman that they would seek a restraining order against him if he persisted in
3 contacting Kardashian. (*See id.*) Bowman has sent multiple email responses to Kardashian’s
4 attorneys which contain bizarre statements and accusations. (*See Reynolds Decl.*, Exs. B - E.) For
5 example, on Wednesday, January 6, 2010, Kardashian’s attorneys received an email from
6 Bowman wherein he stated that he wanted to play the Joker in the next Batman film but that he
7 was “being followed and watched VIA Twitter by Warner Brothers, and personally.” Mr.
8 Bowman stated that “[a]fter watching Governor Schwarzeneggers (sic.) state of address (sic.) it
9 further clarifies im correct. I made Warner a offer of two million dollars for me to play the Joker,
10 but theres more information I have for another Batman movie.” (*See Reynolds Decl.*, Ex. D.)

11 D. Kardashian Fears for Her Safety and the LAPD has Advised Her to Obtain a
12 Temporary Restraining Order

13 Despite the cease and desist letter from Kardashian’s attorneys, Bowman has continued to
14 send her messages via her Twitter account. (Kardashian Decl., ¶ 10.) True and correct copies of
15 an examples of Bowman’s numerous twitter messages to Kardashian are attached to the
16 Kardashian Declaration as Exhibit A.

17 Kardashian is extremely frightened by Bowman because he appears to be obsessed with
18 her and is extremely delusional. (Kardashian Decl., ¶ 11.) He persists in contacting her despite
19 repeated demands that he never contact her again. (*See id.*) She believes she is being harassed by
20 Bowman. (*See id.*) In addition, the LAPD has recommended to Kardashian and her attorneys that
21 they obtain a restraining order against Bowman because he potentially poses a threat to her. (*See*
22 *id.*)

23 III. **A RESTRAINING ORDER SHOULD BE IMMEDIATELY ENTERED AGAINST**
24 **BOWMAN**

25 Code of Civil Procedure (“C.C.P.”) section 527.6(a) provides that “[a] person who has
26 suffered harassment as defined in subdivision (b) may seek a temporary restraining order and an
27 injunction prohibiting harassment as provided in this section.” “Harassment” is defined by
28 subsection (b) as including a “a knowing and willful course of conduct directed at a specific
person that seriously alarms, annoys, or harasses the person, and that serves no legitimate purpose.

1 The course of conduct must be such as would cause a reasonable person to suffer substantial
2 emotional distress, and must actually cause substantial emotional distress to the plaintiff.”
3 “Course of conduct” is defined as “a pattern of conduct composed of a series of acts over a period
4 of time, however short, evidencing a continuity of purpose, including following or stalking an
5 individual, making harassing telephone calls to an individual, or sending harassing correspondence
6 to an individual by any means, including, but not limited to, the use of public or private mails,
7 interoffice mail, fax, or computer e-mail.” C.C.P. § 527.6(b)(3).

8 The evidence presented in the attached declarations of Kardashian, Detective Gregozek,
9 and Jeremiah Reynolds clearly demonstrates that Kardashian is entitled to a temporary and
10 permanent restraining order against Bowman pursuant to C.C.P. § 526.7. Bowman has engaged in
11 a “course of conduct” that “seriously alarms, annoys, [and] harasses” Kardashian and serves “no
12 legitimate purpose.” Despite attempts by the LAPD and Kardashian’s attorneys to get Bowman to
13 stop contacting Kardashian, he has continued to contact her. Kardashian is extremely frightened
14 by Bowman because he is obsessed with her and is extremely delusional. The LAPD had advised
15 Kardashian to obtain a restraining order against Bowman because he poses a threat. Accordingly,
16 a temporary and permanent restraining order should be issued against Bowman.

DECLARATION OF KIMBERLY KARDASHIAN

I, KIMBERLY KARDASHIAN, declare:

1. I make this Declaration in support of the Request for Orders to Stop Harassment against respondent Dennis Shaun Bowman ("Bowman"). Each of the facts stated herein is within my own personal knowledge and if called as a witness, I could and would testify competently thereto.

2. I am a model, actress and television personality. I am perhaps best known for my role on the *E!* reality show "Keeping Up with the Kardashians." I am frequently featured in the tabloids and online media.

3. Beginning in or around late-September 2009, I began receiving messages from Mr. Bowman via my Twitter account. I have never met Mr. Bowman. I do not know who he is. Mr. Bowman is apparently under the delusion that I was and am interested in some sort of romantic relationship with him. Mr. Bowman sends me numerous messages each day telling me, for example, that we are in love, that we will go to dinner together, and that he is going to marry me.

4. Mr. Bowman has made numerous attempts to contact me in person. For example, in late September 2009, I made a promotional appearance at "Famous Cupcakes" in Beverly Hills, California. Mr. Bowman attempted to meet with me at the promotional appearance but arrived after I had already left the location. The staff of Famous Cupcakes informed me that Mr. Bowman acted in an extremely bizarre manner and they were frightened by his actions. I was informed by the staff of Famous Cupcakes that Mr. Bowman returned on three separate occasions looking for me and each time acted in a very bizarre manner. On at least one of those occasions, Mr. Bowman was in the face paint worn by the "Joker" in the Batman comic books. 14 7. In November 2009, I announced on my Twitter page that I had just gotten a
15 smoothie drink at the Body Factory in Santa Monica, California. I was informed by the staff that
16 Mr. Bowman had arrived at the Body Factory sometime thereafter and demanded that he be
17 allowed to see me.

18 8. In November 2009, I made a promotional appearance at the Westfield Mall in
19 Culver City, California. Given Mr. Bowman's strange actions and his numerous previous
20 attempts to contact me, I had informed security at the mall to be aware that Mr. Bowman might
21 attempt to make contact with me. Security at the mall informed me that Mr. Bowman had arrived
22 at the appearance and demanded to speak with me.

23 9. I filed a police report with the Los Angeles Police Department following Mr.
24 Bowman's attempt to contact me at the Westfield Mall. I was informed by the Threat
25 Management Unit of the LAPD that they had interviewed Mr. Bowman on November 17, 2009
26 and had told Mr. Bowman that I did not want to have any contact with him. Despite the order
27 from the LAPD to not contact me, Mr. Bowman continued to send me bizarre messages via my
28 Twitter account throughout December 2009 and January 2010.

1 10. On January 3, 2010, I instructed my attorneys to send Mr. Bowman a letter
2 demanding that he cease and desist contacting me through any means, including Twitter, email or
3 personal contact. Despite the cease and desist letter from my attorneys, Mr. Bowman has
4 continued to send me messages via my Twitter account. True and correct copies of an examples
5 of Mr. Bowman's numerous twitter messages to me are attached hereto as Exhibit A.

6 11. I am extremely frightened by Mr. Bowman because he appears to be obsessed with
7 me and is extremely delusional. He persists in contacting me despite repeated demands that he
8 never contact me again. I believe I am being harassed by Mr. Bowman. The LAPD has
9 recommended to my me and my attorneys that we obtain a restraining order against Mr. Bowman
10 because he potentially poses a threat to me.

11
12 I declare under penalty of perjury that the foregoing is true and correct and that this
13 Declaration was executed this 13 day of January 2010 at Los Angeles, California.

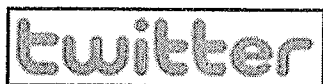

DECLARATION OF DETECTIVE JOHN GREGOZEK

I, John Gregozek, declare as follows:

1. I am a Detective in the Los Angeles Police Department, Threat Management Unit, Serial No. 34087. I have personal knowledge of the facts set forth herein, which are known by me to be true and correct, and if called as a witness, I could and would competently testify thereto.

2. On November 17, 2009, in response to a police report filed by Kimberly Kardashian, I, along with Detective Hoffman, Serial No. 30708, located and interviewed Dennis Shaun Bowman ("Bowman") at a Laundromat where he lived and worked in the city of Calabasas. Bowman stated he moved from Georgia about 2 months ago to pursue a career in acting and performing. Prior to moving from Georgia, Bowman signed up for Twitter and was automatically signed up as a follower to Kim Kardashian ("Kardashian"). Bowman later saw a posting on Kardashian's Twitter page stating that she wanted to have "sweet dreams." Bowman videotaped himself singing a song to Kardashian and sent her the link in a Twitter message.

3. The next day, it was reported in the media that Kardashian had broken up with her boyfriend, Reggie Bush. Bowman told me that he believed Kardashian had broken up with Bush because of his song to her.

4. Kardashian later made a promotional appearance at a nightclub in Atlanta, Georgia, and Bowman he thought that Kardashian was going to Atlanta to have dinner with him. When Kardashian did not show up at the restaurant where Bowman was, Bowman became concerned that he was at the wrong restaurant and had stood-up Kardashian. Bowman attempted to make contact with Kardashian at the night club, but could not get close to her due to the crowd.

5. Bowman stated he moved from Georgia to Calabasas, California because he knew that Kardashian's family lived in Calabasas and hoped to see Kardashian around town. Bowman admitted he made numerous attempts to contact Kardashian, including at her family clothing store located in the city of Calabasas in September, at Famous Cupcakes in North Hollywood in September, at the Beverly Center in October, and the Westfield mall in Culver City in November.

1 Bowman told me he attempted to contact Kardashian because she was not replying to his postings
2 and he wanted to apologize to her for missing their dinner date. Bowman felt Kardashian was
3 offended by him and that he would not get work as an actor as long as she felt this way.

4 6. I explained to Bowman that Kardashian did not know him or desire any contact
5 from him. I further explained to Bowman that his messages and attempts to approach Kardashian
6 in person caused her to be fearful for her safety. Bowman apologized for causing concern and
7 stated he would not contact Kardashian through Twitter or any other means.

8 I declare under penalty of perjury under the laws of the State of California that the
9 foregoing is true and correct.

10 Gregozek recommended that Ms. Kardashian obtain a civil restraining order against Mr. Bowman
11 because he believed that Mr. Bowman would attempt to contact her again in person.

12 7. On January 14, 2010, I provided notice to Bowman that Kardashian would be
13 seeking a temporary restraining order against him on January 19, 2010 in this Court. A true and
14 correct copy of my letter to Bowman is attached hereto as Exhibit F. On January 14, 2010,
15 Bowman responded to my letter with multiple emails containing odd statements and accusations.
16 True and correct copies of Bowman's emails to me are attached hereto as Exhibit G.

18 I declare under penalty of perjury that the foregoing is true and correct and that this
19 Declaration was executed this 19th day of January 2010 at Santa Monica, California.

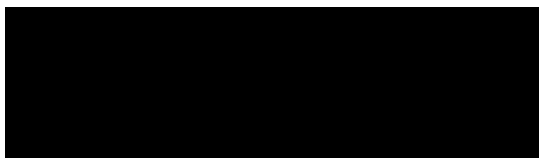




