Kelsey proposes the following, subject to Evidence Code Section 1152:

- 1. Commencing the week of May 16, 2011, Kelsey shall have primary physical custody of Jude and Camille shall have primary physical custody of Mason. The parties shall share joint legal custody of both children. Jude shall fly with Michele to Chicago to be with Kelsey on May 16, 2011. Kelsey proposes that Mason also come to Chicago on May 16, 2011. Michele shall stay with Kelsey and the children from May 16, 2011 and then return with Mason to Los Angeles on Saturday, May 21, 2011. Kelsey shall enroll Jude in classes at the Chicago branch
- 2. Unless either party is out of the country, each parent shall have both children one weekend per month. The parties shall continue to participate in mediation with Dr. Katz to facilitate communication and to agree upon a schedule that ensures frequent and continuing contact between Mason and Kelsey, Jude and Camille, and Mason and Jude.
- 3. With the assistance of Dr. Katz, or other mutually agreed upon mental health professional, the parties shall evaluate the custody arrangement and the impact on the children in May, 2012.

- 4. Camille shall have custody of both children for Mother's Day weekend every year and Kelsey shall have custody of both children for Father's Day weekend every year.
- 5. In odd years commencing in 2011, Camille shall have custody of both children for the month of July and Kelsey shall have custody of both children for the month of August. In even years commencing in 2012, Kelsey shall have custody of both children for the month of July and Camille shall have custody of both children for the month of August.
- 6. In odd years commencing in 2011, Kelsey shall have custody of both children for the Thanksgiving holiday weekend, from after school on the day that school lets out for the Thanksgiving holiday to return to school on the Monday following the Thanksgiving holiday. In even years commencing in 2012, Camille shall have custody of both children for the Thanksgiving holiday weekend, from after school on the day that school lets out for the Thanksgiving holiday to return to school on the Monday following the Thanksgiving holiday.
- 7. The parties shall evenly divide the children's Winter Break from school. In odd years commencing in 2011, Kelsey shall have both children for the first half of the Winter Break and Camille shall have both children for the second half of the Winter Break. In even years commencing in 2012, Camille shall have both children for the first half of the Winter Break and Kelsey shall have both children for the second half of the Winter Break. There shall be no "carve-out" for Christmas Eve, Christmas Day, New Years Eve or New Years Day unless otherwise mutually agreed by the parties. The parties shall exchange the children at 12:00 p.m. on the day that is mid-way through the Winter Break. If the children are let out of school on different dates, whichever child's school lets out the earliest shall be the first day of "Winter Break" for purposes of the parties' custody agreement, and whichever child's school starts the latest after the Winter Break shall be the last day of "Winter Break" for purposes of the parties' custody agreement. Both parties shall be permitted to travel outside of the State of California with the children during their Winter Break vacation periods.
- 8. The parties shall evenly divide the children's Spring Break from school. In even years commencing in 2012, Kelsey shall have both children for the first half of the Spring Break and Camille shall have both children for the second half of the Spring Break. In odd years commencing in 2013, Camille shall have both children for the first half of the Spring Break and Kelsey shall have both children for the second half of the Spring Break. The parties shall exchange the children at 12:00 p.m. on the day midway through the

Both parties shall be permitted to travel outside of the State of California with the children during their Spring Break vacation periods.
