Upon my arrival to the lane, it was passed down to me that 3 ladies from house 91 had jumped over the back wall and left the lane. Myself and two other techs kept watch for the ladies to return. At approximately 12:40am I received a call from the Daisy Lane Night Tech to come and do a breathalyzer test on two of the ladies. When I entered the residence I went to Pt. Shannon S. room and she was not there, I went to Kelly R. room in which was there, I asked about the whereabouts of Shannon S. and Bella G. Kelly said she didn't know where they were. At that time we heard voices coming from the backyard, Kelly and I went outside and I realized the voices were coming from the other side of the wall. There was a chair that had been pushed against the wall so I stood on top of it to find the Daisy Lane Tech and two ladies. I recognized one of the ladies as being Bella G. I couldn't see the face of the other, I then asked John where was Shannon St., Bella G. turned around and said to me "she's standing right here". I then asked both ladies to enter into the house through the front door. They complied, as they were entering the house Bella G. stormed passed me throwing her purse on the couch and stated "I'm not dealing with this BULL__T, you're a rude A_S B__H." I proceeded to breathalyze Shannon, and Kelly, Shannon complied, Kelly was unsure if she should or not. I asked Shannon if she had been drinking, because I could smell the alcohol on her breath she would not answer, I then asked Kelly if she had been drinking, she said yes. I thanked her for her honesty. I then went back into Lindsey's bedroom to ask her to come breathlize, she yelled at me that she was talking to her mother and her mother told her she didn't have to breathalyze, she asked me if I wanted to speak to her mother but would never hand me the phone. I left from out of her bedroom and went back into the dining area to breathalyze Kelly B. Bella G. stormed in the room and told Kelly that she didn't have to breathalyze because her mother said so. Bella G. went back in her room and at that time Kelly B. asked to speak to me in private, we went into Shannon's bedroom and she began to tell me that she was afraid and didn't want to get in trouble by Bella G. At that moment Bella G. busted in the door and grabbed Kelly by both of her arms and stated "Don't tell them anything." I then told Kelly that if she still wanted to talk we could go to the Tech Office she shook her head yes and I told her to go and put some shoes on, she went to her bedroom to put her sandals on all the while Bella G. is following her telling her "Don't go, and don't tell them anything" as Kelly B. and I were walking out of the front door Kelly B. was in front of me, Bella G. came on the left side of me and aggressively grabbed Kelly B.'s right upper arm and told her "Don't go anywhere", I asked Bella G. to let go of Kelly B.'s arm, she finally complied after asking her twice. Kelly then ran over to Shannon and started crying, Bella G. was standing behind her yelling "you don't have to do anything". I was trying to get Kelly's attention and Bella G. turned around and pushed me, on my left shoulder. I called the Daisy Lane Tech for assistance, upon his arrival Bella started yelling at him to "Get out of my house, you don't have a right to be in there because you're a man" he complied and left the house she then said to me repeatedly "Get out of my house". I followed him out to tell him what had happened, I went back into the house to see if Kelly still wanted to talk. Kelly and Shannon were in Shannon's bedroom, after I entered the bedroom Bella walks in behind me with one phone up to her ear and the other phone in her hand and says "The police want to talk to you". I reached for the phone and proceeded to talk to the officer. Bella was still yelling out of control, I told the officer that I had no problem talking to him but Bella was going to keep interrupting at that time she threw the phone that she had at me, I threw up my left hand to block it and then she grabbed my right hand and tried to snatch the phone that I had up to my ear, then called me a "C__T B__H. I said to her "You know that I could press charges against you for putting your hands on me" and she replied "Oh you want money?" I told her this wasn't about money it was about respect which she hadn't shown me any at all. At that point I removed myself from the residence, the officer was still on the phone line, as I proceeded to explain what was going on, an officer drove onto the lane. I hung up the phone a began talking to the officer on the lane, I explained what was going on, he then went inside the house. I called Johanna as

instructed by the Daisy Lane Tech, I explained to her what had happened and gave her clarification on who called 911. I then went back in the house and Kelly breathalized for me and she and Shannon admitted to having dinner with 3 male patients from house 88, they told me that Bella was not with them that she was upstairs getting her hair done, they also wanted me to know that the 3 male patients didn't have anything to drink. I went back outside to let the Daisy Lane Tech know that Kelly did a breathalyzer for me. Shortly after that, Bernie and security showed up on the lane. I entered the house with Bernie per his request once we got to Bella's room she made the statement "I don't want to talk to her" so I left the room and went to talk to the officers. Once Kelly and Shannon had left to go to Ottenstein I returned to the F- YAT house, as I began writing my incident report the M-Yat Tech came and told me that the police were back and needed to talk to me. I went down to the corner to talk to them they wanted a formal statement, so I gave it to them. The officer told me that Lindsay wanted to press charges against me but since I wasn't going to press charges against her she decided not to press charges against. I told the officer that I didn't touch her I only raised my arm to block the phone that she through at me. The only time I was alone with her was when I went into her bedroom to ask her to come do a breathalyzer test, I also told him that I wasn't willing to risk losing my job over any patient. The Officer gave me his information and thanked me for my cooperation.
