PLEASE GOVERN YOURSELF ACCORDINGLY AND BE ADVISED THAT ANY FURTHER AND ADDITIONAL FALSE STATEMENTS MADE BY YOU ABOUT MRS. KRUPA SHALL BE PROSECUTED AS ADDITIONAL CAUSES OF ACTION AGAINST YOU AND/OR UTILIZED TO PROVE ACTUAL OR CONTINUED MALICE.
