**Details of Incident:**

At approximately 9:30pm on the evening of Friday, December 6, 2024, I was notified by Dreamland's programming and events manager Katie McAveety that Linda Holliday (mother of the DJs at the party – Kat and Ashley Hess) had requested to speak with me at the first-floor check-in station. After approaching Ms. Holliday, she let me know that she was upset by the presence of Jordon Hudson, the current partner of her ex-boyfriend Bill Belichick, at the party. Ms. Hudson was a paying guest. No concerns had been raised regarding her behavior nor had any issues been reported up until that point in the evening (the event began at 7pm). Ms. Holliday felt her presence was inappropriate, since the event was widely advertised as a party headlined by her daughters. She asked that I remove Ms. Hudson from the premises, to which I responded that I would speak with Ms. Hudson after contacting Dreamland executive director Alicia Carney to discuss the matter. While on the phone with Mrs. Carney, it was brought to my attention that there was a confrontation in progress in the Studio Theater that Mrs. Carney flagged on security cameras, where the dance floor and DJs were located. Mrs. Carney reported to me that she observed threatening body language and escalating aggression from Elin Hilderbrand and Ms. Holliday towards Ms. Hudson on the security footage and that Ms. Hudson was currently surrounded by three women. I approached the group on the crowded dance floor where more than 200 attendees were dancing, and I noticed several people filming (including Ms. Holliday) a conversation with primarily Ms. Hilderbrand with some commentary from Heather Thorpe and Ms. Holliday. Ms. Hudson attended the event with her friend Melissa Sapini, who is the current titleholder of the Ms. Massachusetts pageant, and was identified as such by her crown and sash. She did not appear to be involved in the conversation and was standing several feet away watching the interaction unfold. When I approached Ms. Hudson, Ms. Hilderbrand, Holliday and Thorpe saw me and backed away while I spoke to Ms. Hudson. Not understanding the origin of the previous conversation at that point, I asked Ms. Hudson if she thought it was a good idea to be there considering the clear animosity the above individuals felt towards her. She defended herself by saying she'd done nothing wrong, and it was her

first time attending Christmas Stroll and wanted to attend the “big party” going on that night, which happened to be the one featuring the Hess Twins. She said she was not looking to cause any problems, but just wanted to go out and have fun with her friend. I reminded her that the other parties found her presence inappropriate and were unlikely to cease their efforts to get her to leave. I let Ms. Hudson know that there were only seven minutes remaining at the event before the lights came up, at which point she agreed that it would not be worth the hassle of staying and agreed to leave if I walked her and Ms. Sapini to the exit. After bringing them to the exit, I pointed out the police detail near the entrance that could assist them if needed as they waited for their transportation, then I went back upstairs to make sure everything was under control. I did not encounter Ms. Holliday, Hilderbrand or Thorpe at this time, so I grabbed a business card and returned to the first floor to give it to Ms. Hudson in case she had any follow-up questions. At this time, she explained to me that her companion Ms. Sapini was seemingly threatened by Ms. Holliday, saying that if Ms. Sapini valued her current title, she should think twice about who her friends are and that she, Ms. Holliday, had many powerful friends in the pageant organization. While Ms. Sapini did not speak, she did begin to cry and moved to the corner of the lobby near the interior box office window and stood there for some time with her back to us, though it was clear she was wiping her eyes frequently. At this point, I wished Ms. Hudson well and returned to the second floor where I encountered Ms. Holliday and others in her party (I did not see either Ms. Hilderbrand or Ms. Thorpe again after the initial encounter). Ms. Holliday asked her party to wait for her on the first floor while she spoke to me, at which point I told her that Ms. Hudson and Ms. Sapini were waiting to be picked up near the exit and suggested no further interaction was necessary. Ms. Holliday thanked me for my help and said something along the lines of “if this didn’t involve my girls, I don’t think this would have bothered me as much, but because it did the ‘momma bear’ in me came out”. At this point I wished a good night, and she presumably left immediately, as live camera footage revealed only Ms. Hudson and Ms. Sapini in the lobby. End.
