**CIRCUMSTANCES OF ARREST**

THAT ON SEPTEMBER 09<sup>TH</sup> 2010 AT 0500 AM, AT THE LOCATION OF [REDACTED] LAS VEGAS NEVADA 89147. JOSIE HARRIS DOB: 01-17-1980 BECAME THE VICTIM OF A GRAND LARCENY OVER 250.00 DOLLARS AND BATTERY DOMESTIC VIOLENCE AT THE HANDS OF HER CHILDREN'S FATHER AND HER EX-BOYFRIEND WHOM SHE IDENTIFIES AS FLOYD MAYWEATHER JR. DOB: 02-24-1977. MAYWEATHER PHYSICALLY ASSAULTED AND BATTERED JOSIE HARRIS AND ALSO TOOK HER CELLULAR PHONE VALUED AT \$ 322.17. THE FOLLOWING DETAILS ARE GIVEN IN SUPPORT OF THE CHARGES.

THAT JOSIE HARRIS WAS OUT WITH FRIENDS AT THE RED ROCK CASINO BOWLING WHEN SHE RETURNED HOME AT 02:30 AM. SHE ENTERED HER RESIDENCE AND FOUND THAT FLOYD MAYWEATHER JR. WAS ALREADY INSIDE AND TALKING WITH HIS AND HER CHILDREN. ( THEY HAVE THREE CHILDREN IN COMMON). MAYWEATHER AND HARRIS BEGAN HAVING A VERBAL ARGUMENT OVER THE HOUSE BEING A LITTLE MESSY. HARRIS ADVISED MAYWEATHER THAT HIS DAUGHTER HAD LOST A TOOTH. MAYWEATHER HANDED HARRIS \$200.00 TO HAVE HER PUT UNDER THEIR DAUGHTER'S PILLOW. MAYWEATHER ALSO GAVE HIS 11 YEAR OLD SON, KORAUN AN "APPLE I-PHONE" AS A GIFT. MAYWEATHER WAS UPSET BECAUSE HARRIS WAS OUT WITH ANOTHER MALE. HE WAS GETTING MORE UPSET AND LOUD, AND HARRIS MADE A PHONE CALL TO THE POLICE. UNDER EVT # 100909-0464, LVMPD PATROL OFFICERS WERE DISPATCHED TO THE RESIDENCE DUE TO A DOMESTIC DISTURBANCE. HARRIS ADVISED OFFICERS THAT NO BATTERY HAD OCCURRED, BUT SHE WANTED MAYWEATHER TO LEAVE THE HOUSE. MAYWEATHER WANTED TO EVICT HARRIS FROM THE HOUSE THAT SHE LIVED IN, BECAUSE HE WAS THE OWNER OF THE HOME. OFFICERS EXPLAINED TO MAYWEATHER, THAT THERE WERE EVICTION PROCESS THAT HE MUST GO THROUGH. (MAYWEATHER WAS BY HIMSELF DURING THIS EVENT) MAYWEATHER UNDERSTOOD THE PROCESS AND LEFT THE PREMISES.

THAT UNDER LVMPD EVENT NUMBER 100909-0684, MAYWEATHER RETURNED TO THE ADDRESS OF [REDACTED] LAS VEGAS 89147 AT APPROXIMATELY 0500 HOURS. MAYWEATHER WAS ACCOMPANIED BY A MALE FRIEND, BY THE NAME OF JAMES MCNAIR. ONE OF MAYWEATHER'S CHILDREN WAS SLEEPING ON THE COUCH IN THE LIVINGROOM. HARRIS STATED THAT WHILE SHE WAS SLEEPING ON THE COUCH, SHE AWOKE TO MAYWEATHER YELLING AT HER AND HOLDING HER CELL PHONE AND READING TEXT MESSAGES ON HER PHONE. MAYWEATHER BEGAN YELLING AT HARRIS "ARE YOU HAVING SEX WITH C.J.?" HARRIS REPLIED, "YES, THAT IS WHO I'M SEEING NOW". MAYWEATHER GRABBED HARRIS BY HER HAIR AND BEGAN STRIKING HER IN THE BACK OF HER HEAD WITH A CLOSED FIST SEVERAL TIMES. MAYWEATHER PULLED HARRIS OFF THE COUCH BY HER HAIR AND TWISTED HER LEFT ARM. HARRIS STATED THAT MAYWEATHER BEGAN YELLING AT HARRIS "I'M GOING TO KILL YOU AND THE MAN YOUR ARE MESSING AROUND WITH". HE ALSO STATED "IM GOING TO HAVE YOU BOTH DISAPPEAR". HARRIS TRIED TO FIGHT HIM OFF OF HER, AND SHE THOUGHT HE WAS TRYING TO BREAK HER ARM BY TWISTING IT BEHIND HER BACK. HARRIS SCREAMED FOR THE KIDS TO CALL THE POLICE OR RUN TO THE SECURITY GUARD STATION. MAYWEATHER TURNED TO THE KIDS AND YELLED AT THEM THAT "HE WOULD BEAT THEIR ASS IF THEY LEFT THE HOUSE OR CALLED THE POLICE". THE CHILDREN WERE ABLE TO GET OUT OF THE HOUSE AND RUN TO

THE SECURITY GUARD STATION. MAYWEATHER THEN TOLD HIS FRIEND MCNAIR TO GET THE CHILDREN, BUT THEY WERE ALREADY AT THE SECURITY GUARD STATION.

THAT MAYWEATHER'S SON, KORAUN MAYWEATHER, DOB: 11-17-99, ADVISED THAT HE SAW HIS DAD WAS ON HIS MOTHER AND WAS HITTING AND KICKING HER. KORAUN STATED THAT HIS FATHER'S FRIEND, JAMES WAS BLOCKING THE STAIRS, SO HE RAN OUT THE BACK OF THE HOUSE TO THE CASITA. KORAUN KNOCKED ON THE DOOR WHERE HIS MOTHER'S FRIEND, GEORGIA PARKER LIVES. GEORGIA PARKER RAN AROUND TO THE FRONT OF THE HOUSE AND CALLED POLICE. KORAUN RAN DOWN TO THE GATE. JAMES MCNAIR WAS WALKING DOWN TO GET HIM, AND KORAUN JUMPED THE GATE AND WENT TO THE SECURITY OFFICER. KORAUN STATED THAT HIS FATHER AND JAMES GOT INTO HIS FATHER'S VEHICLE AND LEFT OUT THE FRONT GATE. KORAUN STATED THAT HIS FATHER TOOK HIS CELL PHONE, HIS BROTHER'S CELL PHONE AND HIS MOTHER'S PHONE.

LVMPD OFFICERS ARRIVED AT THE SCENE AND JOSIE HARRIS WAS TRANSPORTED TO SOUTHERN HILLS HOSPITAL AND TREATED FOR MINOR FACIAL INJURIES AND SORE LEFT ARM. A CRIME REPORT WAS COMPLETED UNDER LVMPD 100909-0684. DETECTIVE R. SCHMIDT P#3389 CONDUCTED A VERBAL INTERVIEW WITH JOSIE HARRIS AT SOUTHERN HILLS HOSPITAL. SCHMIDT ALSO TOOK DIGITAL PHOTOGRAPHS OF HARRIS' INJURIES AND DOWNLOADED THEM INTO THE LVMPD ON-BASE SYSTEM. MAYWEATHER CALLED GEORGIA PARKER ON HER CELL PHONE AT [REDACTED] AT 0626 AM, WHILE SHE WAS IN THE WAITING AREA AT SOUTHERN HILLS HOSPITAL WAITING FOR JOSIE HARRIS. MAYWEATHER TOLD PARKER TO "GET OUT OF THE HOUSE" AND THAT HE HAD JOSIE'S CELL PHONE. PARKER HUNG UP ON MAYWEATHER.

FLOYD MAYWEATHER JR. WAS LISTED AS THE PRIMARY AGGRESSOR IN THE DOMESTIC BATTERY AND ALSO THE PERSON WHO WITHOUT PERMISSION TOOK THE CELL PHONE OF JOSIE HARRIS. THE CELL PHONE THAT MAYWEATHER TOOK FROM HARRIS IS AN APPLE I-PHONE 4, WHICH WAS PURCHASED BY HARRIS IN RALEIGH, NORTH CAROLINA AT APPLE [REDACTED] THE PHONE PURCHASE AMOUNT WAS FOR \$322.17. HARRIS BOUGHT THE PHONE USING HER BANK OF AMERICA DEBIT CARD. (SEE ATTACHED BANK OF AMERICA RECEIPT AND AT&T RECEIPT FOR FURTHER) (1 CT - GRAND LARCENY)

THAT ON 9-10-10, AT APPROXIMATELY 0930 HOURS, FLOYD MAYWEATHER JR., AND HIS ATTORNEY, KAREN WINKLER CAME TO [REDACTED] LAS VEGAS, NV, AT THE ISD DETECTIVE OFFICE TO TURN HIMSELF IN. THAT DETECTIVE R. SCHMIDT P#3389 PLACED FLOYD MAYWEATHER JR., UNDER ARREST FOR GRAND LARCENY AND A CHARGE TO BE CONSIDERED, FOR 1 COUNT - BATTERY DOMESTIC VIOLENCE. HE WAS TAKEN TO CCDC AND BOOKED ACCORDINGLY.
