THIS AGREEMENT is made the 1<sup>st</sup> day of OCTOBER

1962 BETWEEN NEMS ENTERPRISES LIMITED whose Registered Office is situate at 62/72 Walton Road in the City of Liverpool (hereinafter called "the Manager") of the first part JOHN WINSTON LENNON of 251 Menlove Avenue GEORGE HARRISON of 25 Upton Green JAMES PAUL McCARTNEY of 20 Forthlin Road and RICHARD STARKEY of 10 Admiral Grove, all of Liverpool aforesaid (hereinafter called "the Artists") of the second part and HAROLD HARGREAVES HARRISON of 25 Upton Green (hereinafter called "Mr.Harrison") JAMES McCARTNEY of 20 Forthlin Road (hereinafter called "Mr.McCartney") both of Liverpool aforesaid of the third part \_\_\_\_\_

WHEREAS:

A. The Artists are desirous of performing as a group of musicians to be known as "THE BEATLES" and pursuant thereto of taking engagements in the following branches of the entertainment industry:-

- (a) Vaudeville and revue
- (b) Motion Pictures
- (c) Balls and Dances whether of a private or public nature
- (d) Radio and Television broadcasting
- (e) Concerts, private parties, cabarets
- (f) Phonographic and tape recording
- (g) Sponsorship projects

B. The Artists have agreed to appoint the Manager to be their Manager upon the terms and conditions hereinafter appearing and the Manager has agreed to act as such Manager upon the said terms and conditions \_\_\_\_\_

C. Whereas Mr.Harrison and Mr.McCartney have both approved all the



of them desire to remove one or more of the other Artists then with the consent in writing of the Manager they shall give notice in writing by registered post to the last known address of those other Artists that they be no longer members of "THE BEATLES" and one calendar month from the posting of such notice those Artists so served shall no longer be members of "THE BEATLES" and shall no longer be entitled to use the name of "THE BEATLES"

6. THIS Agreement shall be interpreted under and pursuant to the Laws of England and should any dispute arise between the parties hereto it is agreed that it shall be referred to Arbitration the Arbitration Board to consist of one member to be appointed by the Variety Artists' Federation and one member to be appointed by the Council of the Agents' Association with an independent Chairman and no matter shall be heard by the said Arbitration Board unless notice thereof has been given to the person or persons against whom any complaint is made and the said Arbitration Board is appointed within 12 months of the happening of the event or events giving rise to the said dispute and the making of an award by the said Arbitration Board shall be deemed to be a condition precedent to any right of action in the Courts in respect of the said dispute

7. THIS Agreement may not in any way be enlarged modified or altered except by a separate Agreement in writing signed by all parties hereto
