# Artist Recording Contract:

Artist who are apart of the Group DREAM5

Agreement made as of the 30 (day of week) May (month) in the  
Year of 2009 (current year) between Dream Projects Entertainment  
(Management/Production/Special Events/Record Label Company) hereinafter referred to as "Dream  
Projects Entertainment" and the artist who's name has been printed on the first page of the document,  
hereinafter refereed to artist, or the artists.

## WITNESSETH:

Whereas, the artist is a singer and performer; and  
Whereas, Dream Projects Entertainment is a record company, record producer, record promoter, artist manager, and among its numerous other functions, markets musical compositions and performances; and whereas, the parties are desirous of entering into a contract whereby the ARTIST will record songs, perform, and do all required acts as an entertainer, for Dream Projects Entertainment and Dream Projects Entertainment will attempt to market the same for a period of 2 years commencing with the date of the signing of this agreement. It is also understood that this contract at anytime may be cancelled by non other than Lawrence D. Franklin. By signing this agreement you also agree to give exclusive and administrative rights of your likeness/image/ and voice to only Dream Projects Entertainment for commercial, marketing, entertainment and promotional use, however this will not become active until the 1<sup>st</sup> side is released in stores or is publicly broadcasted, via radio, television, or internet. It is understood that Dream Projects Entertainment owns the exclusives and administrative rights to all Sides recorded with Dream Projects Entertainment and its artist, this includes all music released world wide. Now therefore in consideration of these presents (those signing the contract) and of the mutual benefits and obligations hereinafter contained, the following agreement is made:

## Definition of Terms

For the purpose of this Agreement, the following terms shall have the following meanings and the entirety of the term is expressed within the body of this contract:

1. "Side" means the equivalent of a single compact disc cut, or single song, or a single sound track or the equivalent of a 7 inch 45 rmp, single-sided recording used in international and national radio, embodying the recorded performances of the artist and intended for the use and manufacture of phonograph records, cassettes, cas-singles, or compact disc units or 45 rpm records in the international markets or any other form of music that is currently present on the internet or other cyber area in MP3 format or any future format.
2. "Single" means a single song embodying the recorded performances of the artist and intended for use in the manufacture and distribution promotion of the artist during the 2 year period of the artist is under contract. Because of the recent environmental concerns at many levels in the music industry, all artist single releases are done locally, nationally and internationally, and in some cases in compilation with other artists on the same or other record labels. Usually the various mailings are done in compilation with half of the roster being songwriter clients and the other half being artist clients and the record label is the promoting.
