I, the undersigned complainant, upon my oath or affirmation, state the following is true and correct to the best of my knowledge and belief. On or about 1/23/2010 in Cabell County West Virginia, in violation of W.Va. Code (cite specific section and/or subsection) 61-8B-7 **Sexual Abuse in the first degree** the defendant did:

a) A person is guilty of sexual abuse in the first degree when:

(1) Such person subjects another person to sexual contact without their consent, and the lack of consent results from forcible compulsion

(b) Any person who violates the provisions of this section shall be guilty of a felony, and, upon conviction thereof, shall be imprisoned in a state correctional facility not less than one year nor more than five years, or fined not more than ten thousand dollars and imprisoned in a state correctional facility not less than one year nor more than five years.

I further state that this complaint is based on the following facts:

While inside "Rum Runners" at 819 3rd Avenue in Huntington, Cabell Co., the victim, Justin [REDACTED], was speaking with the defendant. When the defendant (unexpectedly and without invitation) grabbed the victim's crotch, repeatedly groping then kissing him. The incident was witnessed by the victim's girlfriend, Wendy [REDACTED].

Once inside the establishment, the victim, Phillip [REDACTED], (a security guard with Rum Runners) approached the defendant requested the defendant to place an armband on his hand to comply with the rules of the establishment. According to the victim, the defendant grabbed the victim's crotch and began laughing.
