RE: Clemency for Terrell Davis, Case No. 1:20-CR-509-MLB

Dear President Biden:

On behalf of Terrell Davis and his family, we strongly urge you to grant clemency for Mr. Davis, who is serving federal time for non-violent marijuana offense. The undersigned—musicians, actors, athletes, filmmakers, current and former elected and appointed government officials, advocates, and business leaders—strongly believe that justice necessitates the exercise of clemency in this case. Our nation's view of cannabis has evolved, and it is indefensible to incarcerate citizens based on the unduly harsh attitudes of past generations.

Terrell Davis, professionally known as Ralo, is an acclaimed recording artist who made the mistake of selling marijuana and was arrested in 2018. He now faces over 8 years in prison for violating the same federal statute that many entrepreneurs and corporations violate every day in 36 states across the country, who are not subject to federal prosecution. While Mr. Davis was not operating in compliance with state marijuana laws, a federal district court noted that the

recent "shift from prohibition to regulation moves marijuana-related offenses further from traditional drug trafficking offenses and closer to black marketeering in terms of severity."

The state of marijuana laws in the United States has rapidly changed over the last 10 years. For instance, 15 states and the District of Columbia have enacted adult-use policies and 36 states have legalized some form of medicinal cannabis. In 2017, then-President Donald Trump, a Republican, expressed support for ending the federal ban on marijuana. In November 2019, during a Democratic Primary Debate, you stated: "I think we should decriminalize marijuana, period. And I think everyone — anyone who has a record should be let out of jail, their records expunged, be completely zeroed out." 5

Following the lead of voters, in November 2020, the House of Representatives passed the Marijuana Opportunity, Reinvestment, and Expungement (MORE) Act, a law that would remove cannabis from the Controlled Substances Act and thus end federal prosecutions of marijuana offenses. However, despite this nationwide shift in attitude towards marijuana, there tends to lack any real avenue of relief for those who are still serving lengthy federal prison terms for selling cannabis. Given the gridlock in Congress and the imperative of freedom, clemency is the right tool to fix this problem.

While your predecessor commuted the sentences of over a dozen individuals who were serving lengthy prison sentences for marijuana, the vast majority of those serving time for marijuana in the federal system were left behind, including Mr. Davis, and public attention focused on the disparity between those deserving of presidential clemency and those who were wealthy or connected enough to lobby the White House. That form of clemency needs to be replaced with a principled, active, and meaningful program that better fits modern America.

You alone have the power to call out a grand hypocrisy of prior administrations. While cannabis became a thriving, legal market and enriched many, your predecessors largely ignored people like Mr. Davis, who are still serving lengthy federal prison terms for doing the same thing.⁷

In light of the current circumstances and the increased COVID-19 health risk, we respectfully urge you to immediately grant Terrell Davis a presidential commutation of sentence. He has already served three years in prison. This should be enough.
