

I, Holly Marie Smith (name of person) request this Court to issue a Civil Protection Order, and in support of this request state the following:

1. I am seeking this Civil Protection Order as a victim of the following: (Mark the applicable circumstances.)

2. I reside or am employed in the County of Adams, State of Colorado, and Ivan Lewis Greening (name of person) resides or is employed in the County of Adams, State of Colorado. I know Ivan Lewis Greening (name of person) because: He is my husband.

I have completed and attached the form titled "Affidavit Regarding Children" JDF 404 as children are identified as Protected Persons above.

4. a) The most recent incident that causes me to ask for a Civil Protection Order occurred on or about August 3, 2015 (date), at about 1:30 p.m. (time), in Adams (County), when Ivan Lewis Greening (name of person) did the following to me and/or the above named Protected Persons: *Be specific: What was the threat or acts of violence? Where did this occur? Were the minor children or other Protected Persons present? Was a weapon involved?*

At approximately 11:30 a.m. I received an email from Ivan's accountant stating that Ivan wanted to help me with the cost a move by giving me money as long as I signed an attached contract. Once I reviewed the contract I went to find Ivan to discuss the situation. When I showed up I asked him if we could speak outside. I asked him about the contract and I told him that I was going to have an attorney review the contract. Ivan reacted by telling me to "just fucking sign it." I told him that I would have an attorney tell me if it was ok to sign the contract or not. Ivan responded by stating that "If you don't sign the contract I will have all you stuff put outside on the lawn." I told Ivan that I would call the police if he put my stuff out on the lawn however, he responded that "go ahead, I know most of them anyway." I am fearful that with filing the dissolution paperwork, that he will retaliate as I believe he would follow through with his threat to remove all my belongings from our home and put them on the lawn. Ivan has been constantly verbally and physically abusive which causes me to fear for my safety.

- b) The most serious incident that causes me to ask for a Civil Protection Order occurred on or about April 22, 2015 (date), at about 4:00 a.m. (time), in Clark (County), when Ivan Lewis Greening (name of person) did the following to me and/or the above named Protected Persons: *Be specific: What was the threat or acts of violence? Where did this occur? Were the minor children or other Protected Persons present? Was a weapon involved?*

We had both been drinking throughout the night and Ivan accused me of cheating on him. He got very angry with me we had a verbal altercation. When Ivan fell asleep his phone continued to light up with text messages from other women. Ivan woke back up and I confronted him about it and we had another fight at which time he locked me out on the patio. Ivan finally unlocked the patio door and I went into the hotel room. I went to bed to sleep and I woke up with Ivan on top of me and he was holding me down in a Jiu-jitsu submission hold where I was unable to defend myself. He put the blanket over my face and hit me in the face and then he took the blanket and shoved it into my mouth to the point that I could barely breathe and I had a busted lip. I didn't move and when he removed the blanket - I told him to get off me so that I could go to the bathroom. When he got off me I ran to the front desk at the hotel and asked for help. At which time the hotel staff called the police and I waited for the Las Vegas Police Department to arrive. Ivan was arrested for felony domestic battery via strangulation, a second degree felony. As a result of his prior physical abuse I am fearful of his reaction when he is served with the dissolution paperwork. This incident occurred at the Hilton Garden Inn, Las Vegas, Nevada.

- c) Any other past incidents of violence or threats? *Be specific: What was the threat or acts of violence? Where did this occur? Were the minor children or other Protected Persons present? Was a weapon involved?*

Ivan is constantly verbally abusive towards me, calling me names and is demeaning. He has basically called every name in the book and he threatens to kick me out of the home all the time. On one occasion in October when I asked him about texts he received from other women he got very angry with me and took my phone and threw it at me, hitting me in the eye. This occurred on his tour bus in Pennsylvania. Ivan and I had an altercation in January of 2015 when he got so angry that he constricted my breathing and due to the pressure I ended up with a busted blood vessel in my eye.

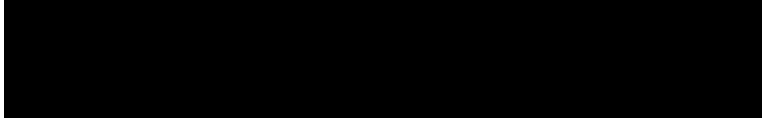
