## OVERVIEW OF INCIDENT

State Police were dispatched to an alarm at Litchfield Bank Corporation in the Town of Salisbury. Upon Arrival it was determined that forced entry was used to enter the building. Upon a search of the building police confronted a white male within the premises , who was later identified as Elmore "Rip" Torn. It was then determined that this individual was armed with a loaded revolver and was highly intoxicated. Torn was taken into custody without incident. Torn was transported to Troop B in North Canaan and processed according to department policy and procedures. Torn is being held on a \$100,000 cash bond and is scheduled to appear at GA 18 in Bantam on 2/1/10.
