DECLARATION OF OKSANA GRIGORIEVA

I, Oksana Grigorieva state of my personal knowledge as follows:

1. The computer data seized pursuant to the warrant contains personal material including photographs of me while pregnant, photographs of me breast feeding my child, my art work, my musical compositions including unfinished projects, family videos, private journals and other private items. It also includes communications with numerous attorneys and doctors.

2. The computer data seized pursuant to the warrant also contains materials that are personal to me and Mel Gibson including videos. These have nothing to do with any criminal investigations or custody matters. They are not X rated or R rated, they are simply personal and they document a time in our lives that belong to us and no one else. They should not be seized only to be seen by others or leaked on the internet.

3. The computer data seized pursuant to the warrant contains materials relating to our daughter Lucia, my son and Mel Gibson's sons. None of this material is remotely related to any investigation of the criminal matters.

4. I have never consented to the release of these materials or other materials that are constantly flooding the internet. There have been false accusations that I have done this but I have not. I have a right to privacy and I am asserting that right.

5. There has been no waiver of privacy as to these materials by me and no waiver of any privileges with respect to the materials on the computer.

6. The mediation produced a document titled "Term Sheet". The "Term Sheet" references an almost \$ 3 million dollar value to my album and videos. The cost of producing the album was far less than that.

7. I estimate the value of the rental of my home at \$ 7,000 per month.

8. My prior attorney is seeking \$ 1.5 million dollars in fees for assisting in negotiating the agreement.

9. The mediation agreement does not reflect any extortion by me. To the contrary, I

1 signed the agreement only because I felt threatened. I believed that I would be arrested, deported
2 and deprived of custody of Lucia if I did not sign.

3 10. The threat is now being carried out as I understand that if I am convicted of extortion
4 I could be deported and I would lose Lucia.

5 11. Exhibit 1 is a true and correct copy of an E-mail that I sent to Mel Gibson on March
6 30, 2010.

7 12. Exhibit 2 is a true and correct copy of a portion¹ of a text sent by Mel Gibson to me
8 prior to my signing a cohabitation agreement. The date of the text is November 14, 2009.

9 13. Exhibit 3 is a series of texts between me and Mel Gibson on March 22, 2010. This is
10 prior to the mediation.

11 I declare the above to be true and correct under penalty of perjury. Executed on October
12 11, 2010 at Sherman Oaks, California.

I don't believe that you stopped loving me just in one phonecall. You either stopped loving me a long time ago or you still love me. I'm saddened, that you're so easily influenced by others, whose agenda purely to have you function as an entity and blaming your nervous breakdown on me. Which is not true. That's what you want to hear and they giving it to you.

You have the issues with your mother, the influences of Robyn and Hanna, just like French court, the issues of dynasty and power have come to play (they are at its peak now) and it's easier to blame the outsider, your love, completely unprotected. So you betray me.

Love like that doesn't die so quickly. Despite all the pain I endured, I still love you. But, clearly, I do not see a way back after such betrayal of our little family. You always said you're here for a long hold and that's what I believed.

I still don't know what I've done to you to be treated the way I have been.

I'm seeing a therapist every day and my eyes are opening up to so many understandings as what really happened from the very beginning of this saga.

Oh, my King! Good luck to you!

I'm going to the church with Lucia and I'm praying every day to your healing and to mine.

We had one of the most rare loves, we should have cherished it.

Before I wrote this letter to you I asked God's permission and he granted it.

Forgive me for my occasional weakness and for not being able to set the boundaries and for my occasional insecurity.

I loved you so much, I couldn't even look at another man. Why was there so much jealousy and anger.

As far as the tapes go. I only played one to my lawyer, because on March 15 Michelle proposed on your behalf not a very generous gift for our daughter and there was nothing for me. My lawyers also told me that Tom Hansen said I wouldn't get a penny and more importantly, my lawyers warned me that your lawyers are capable of false fabrication about me in press, i.e., an unfit mother, a prostitute etc so you can have the baby and I get to go to my "f...ing moth hole" as you told me.

I had no choice, after all of this I had to play one message to them.

I'm sorry, there was too many threats coming from your lawyers and I do not believe that you didn't control this whole show.

The messages we're talking about I kept on my phone purely for you, to see how scared we were and for you to understand what this has done to us, how painful these words were, but hopefully, eventually, to help us. That was the only reason.

If you honestly kept your word that you gave on the bible to take care of us and to protect us, there would be no need for lawyers, who really do not care for us, yet they managed to help with our separation.

I thank God for his immaculate interception in so many ways. Even the texts evidently

send to me , but ment for smone else is Godsend , telling to me. And ur immidiate reaction to that was weekness and pleasing to somone, who was putting me down,who has got ur car at the moment. Tells u what u really want to hear.

Thank u for taking the first stepp.

I wish u happiness and peace.

I'm finally obtaining mine.

It's a great shame.

U were the love of my life.

We have to be friends for Lucia and we have to respect one onother.

I alwayes respected u and wearshipped ur extraordinary talents, but I loved u as a man, as my best friend, who was funny and sweet. I will pass all of this to our daughter, I give u my word. She will love and respect u more then anyonelse.

I know u r trying to c Lucia. Next Saturday would be great, at Bobstone pls. I will be here becouse I'm working on my piano, I have no desire to speak to u. But I might pop out for an hour whilst u here, if all cool.

I do appoligise, but Lucia is just too small for me not to be around her at the moment. When she will walk and talk u will be able to c her in different circumstances.

There also be Edith and Tracy,who is staying with me.

Pls let me know if that's agreeable.
