- 1. On Wednesday, November 22, 2017, at approximately 11:10AM, Detective Brett Morneau and I interviewed William N. Little (DOB: 1/19/98) at the Cape and Islands District Attorney's office in Barnstable. The interview was in regards to allegations Will has made that Kevin Spacey Fowler (DOB: 7/26/59), hereinafter referred to as SPACEY, sexually assaulted him at the Club Car in Nantucket on July 7, 2016. Will had previously reported the assault via telephone to Nantucket Police Officer Kelly on October 31, 2016 (see attached).
- 2. Will gave us the following account of what transpired between July 7, 2016 and July 8, 2016:
  - a. Will was working at the Club Car on Nantucket as a bus boy. He started work at 4PM and his shift typically ended around midnight. Will and the other employees had a staff meal before he started busing tables at approximately 5:30PM. It was at the beginning of his shift, or maybe in or around the staff meal, when Will learned SPACEY would be at the Club Car. SPACEY arrived at approximately 11:30PM when Will was still working. Will had heard he'd arrived and saw SPACEY standing at the bar. SPACEY was with his manager, who Will said was a Duke graduate. Will never waited on SPACEY while he was working. Will's work attire was very formal so he brought a change of clothes which he changed into when his shift ended around midnight. Will said there might be an

electronic time card indicating when he punched out. I asked about video surveillance in the restaurant, but Will said he didn't think there was one.

- b. SPACEY and his manager were sitting at a table across from the bar, near the front door, speaking with Will's friend, Nick Uzelak. Nick was the doorman/bouncer of the Club Car, but was not working that night. Will pulled Nick aside to ask Nick to introduce him to SPACEY since it looked like they were hitting it off. Nick said, "I thought I would just stop by to say hello." Nick told him it wouldn't be a problem. Nick didn't believe SPACEY took any pictures with people in the Club Car that night.
- c. Will thinks it was between 12:00 and 12:30AM when he was introduced to SPACEY. He changed up after his shift ended at approximately midnight, spoke to some co-workers, and then went over to where SPACEY was sitting. SPACEY was sitting at the tables across from the bar, but not at the bar itself. Nick introduced them and SPACEY asked where Will was from to which Will responded, "Boston". SPACEY told Will how his dog is named Boston because he got it in a hospital in Boston after the marathon bombings. SPACEY asked Will how old he was and Will told him he was twenty-three. SPACEY asked Will where he went to school to which Will responded he went to Wake Forest and was studying business. Will was sitting at the table with everyone at that point. SPACEY's manager, Nick and his friend were around in the bar. SPACEY told Will his manager could get him a job. Will spoke to the manager and tried to talk "shop" about business, but Will didn't know much really. Will said it was because he was really only 18 and had not even started college yet. SPACEY had been at the bar while Will spoke to the manager, but came back to Will when the conversation ended.
- d. SPACEY asked Will if he wanted a drink and Will said, "Yes, a Stella." The drink buying continued throughout the night. Will estimated the first drink was prior to 12:30AM with the bar being open pretty late and Will thinking he was there until 1:30AM. Will said the bar typically closed at 2AM. Will described that night as busy and crowded. Will said again they were near the front door and then he and SPACEY moved to where the piano was.
- e. The drinks continued constantly through the whole night. Things started to get a little fuzzy when Will and SPACEY went over to the piano. Will said he had at least 4 or 5 beers before SPACEY said they should switch to whiskey adding, "Let's get drunk." Will said he and SPACEY had 4 to 5 glasses of whiskey. SPACEY was buying drinks for just the two of them, but the manager may have sometimes bought drinks for them, but Will thought it was mostly just the two of them. Will said there were 3 or 4 drinks prior to going over to the piano and he wasn't sure what they were talking about while at the

table. At the piano, Will said they were doing sing-alongs and SPACEY had his arm around Will. Will said he hadn't had any drinks before SPACEY bought him the first beer.

- f. Will did say while they were at the table they spoke about his girlfriend and SPACEY asked how long they'd been dating. Will told him 5 months and SPACEY said that was nothing. Will had been texting her and SPACEY told him to stop talking to her. The bar was noisy with people talking and the piano playing. SPACEY asked Will what he was packing and Will knew what he meant due to the context of the conversation they were having about Will's girlfriend. Will told SPACEY he was average and SPACEY told Will his dick was 8 inches long. Will said he did not know how to respond to that.
- g. Will said there wasn't much else prior to the piano as far as conversation went. Will said he was wearing shorts and a button-down shirt. Will described the shirt as a red, loose button-down shirt.
- h. Will said they had both headed over to the piano together. They were singing along together, having a good time. The piano player was one of two guys who play the Club Car all summer. Will said they went to the piano before 1AM, maybe 12:45AM or 12:50AM. Will said he and SPACEY exchanged numbers before they went to the piano. SPACEY told Will he would be there for the rest of the week. SPACEY said he was going to the brewery and they should exchange numbers so they could meet up later. SPACEY knew Will worked at the Club Car. Will said drinks were still coming while they were at the piano. Will remembered the bartenders were Peggy and Dave. Will felt they knew he was there and that he was with SPACEY.
- i. They were mostly just singing at the bar when around 1AM they went outside to smoke a cigarette. Will doesn't usually smoke so SPACEY was the one who brought it up. They went to the back bench behind the Club Car. There SPACEY asked Will if he wanted to go back to his house with his friends. Will told SPACEY he had to work the next day and he had to get home because he was staying with his grandma. Will said he didn't want to go back to SPACEY's because the request seemed weird based on SPACEY's earlier comment about his dick. Will said he saw that comment as a red flag and did not want to go back to SPACEY's house. SPACEY pressed Will on going over his house and said a ride home wouldn't be a problem, they would get him a taxi or Uber. SPACEY told Will he could have that picture he wanted. It all seemed like a come-on to Will. He thought Kevin SPACEY was gay and trying to get him back to his house.

- j. They finished smoking the cigarette outside and they went back inside to the piano. Will was uncomfortable when they were inside. Will only lingered around because he wanted a picture with SPACEY, something for Instagram. SPACEY had told him if you come back with me, I will take a picture with you. Will had asked earlier, but SPACEY had said no because then he'd have to take pictures with everyone. SPACEY did sign his autograph on a torn menu for Will and Molly. Will's autograph said, "Your turn at drinks" and Molly's said "Always Smiles". SPACEY signed the autographs in the area of the piano, before they went outside.
- k. Will thinks they were outside smoking a cigarette for about 10 to 15 minutes. SPACEY was persistent in trying to get Will back to his house.
- When they went back to the piano, it was still very crowded. SPACEY was standing in front of Will, to Will's right. SPACEY used his left hand and started rubbing Will's thigh. SPACEY worked his way up to Will's zipper. Will said this happened quickly. SPACEY unzipped his pants. Will wasn't sure if SPACEY went into his pants through the open zipper, but over Will's pants and boxer shorts, putting his hand on Will's penis. Will described it as a sexual manner. Will was asked to expound upon that and he described SPACEY to be rubbing his dick. Will didn't know what to do. He didn't want to get in trouble at work or get his work in trouble. He knows he's only 18, he's not supposed to be drinking, and he's not supposed to be drinking at his work. While SPACEY is touching his penis, Will was texting and snapchatting. Will thinks the touching went on for about 3 minutes. SPACEY goes back and forth, in and out of his pants several times, more than two to three times, but closer to several times. SPACEY continued the touching through the top of Will's pants. He didn't go in through the fly.
- m. SPACEY didn't say anything before he touched Will or during the touching or after the touching. Will didn't say anything to SPACEY either. Will could've moved away, but it was crowded. Will didn't get an erection and he said he wasn't gay. Will described it as SPACEY trying to jack him off, the way SPACEY was playing with his dick, but Will wasn't erect. Will tried to shift away with his body and move SPACEY's hands away with his hands, but SPACEY kept reaching down his pants.
- n. Will said his girlfriend did not believe him so that's when he snapchatted the video. The video is one of the last times SPACEY touched him. Will said he had his phone in his left hand and he may have had a glass of whiskey in his right hand. SPACEY then stopped and left to go to the bathroom. Will couldn't remember if he approached a woman or if a woman approached him, but she saw he was in distress. Will told her he thought

Kevin SPACEY is trying to rape him. She told him to go so he did. Will went out the back door and ran up Main Street until he got home to 26 Milk Street.

- o. Will was shown the video he said was of SPACEY touching him and Will was wearing a blue shirt. Will said that was right, it was a blue shirt. SPACEY was wearing a ball cap, a grey, tweed blazer and pants.
- p. While he was on his way home—about half way up Main Street—Will received a text from SPACEY saying, "I think we lost each other". Will did not respond to the text. Will got home and woke up his sister, Kayla, to tell her what happened. Kayla then called their mom. His parents were home in Dover, but Will's mother came to the island the next day. Kayla told Will he woke up around 4AM and started pacing around the room.
- q. Will said the whole thing was embarrassing and has not had a "profound emotional effect" on him. Will told his friends about it and he makes jokes about it because that's his way. Will called the police because he doesn't want what happened to him to happen to anyone else.
- 3. At the end of the interview, Will said he still went to work the next day, but told the owner, Joe, what happened because he wanted to leave if Kevin SPACEY came back. According to Will, Joe asked him if it was his first time being hit on by a guy. Will said his mother told him that day to call the police, but Will did not want to get anyone at the bar in trouble. Will described the woman who told him to leave as in her 30's or 40's, pretty, possibly blonde, but he'd never seen her before. I asked Will if he'd been drunk before and Will said he'd been drunk a lot and has blacked out before. Will said his senior year was very good. I asked Will if he blacked out that night and Will said not at the restaurant, but he didn't remember pacing around like his sister said. I asked if he made it home safely and Will said he did, but he was definitely hungover the next day before he went to work at 4PM.
- 4. The interview concluded at 1:02PM.

- 1. On Monday, December 18, 2017, at approximately 2:55PM, Sergeant Scott Brightman and I interviewed Molly Doyle (DOB: 8/27/97) relative to her knowledge of an alleged sexual assault that occurred after midnight on July 8, 2016 on Nantucket. Molly was dating the victim, Will Little, and the two had been in contact throughout July 7th and July 8th 2016 via text message. The suspect of the sexual assault is Kevin Spacey Fowler, hereinafter referred to as SPACEY. Molly was the first person Will told of the sexual assault.
- 2. The interview took place at Molly's residence and Molly gave us the following account based on her recollection:
  - a. Molly was in Rhode Island at her summer house in Bonnet Shores. She and Will had been dating for approximately 5 months and the two had been texting throughout the day of July 7th. Sometime during the evening of July 7th, while Will was at work at the Club Car, he texted her and told her SPACEY was expected at the Club Car later that night. Molly didn't know who SPACEY was so she looked him up and saw he was on the Netflix series, House of Cards. Molly asked Will to get an autograph for her and Will said he'd get an autograph and a picture. Molly felt Will would be excited to meet SPACEY and that he would be "starstruck". Molly received texts from Will after Will met SPACEY and Molly could tell Will was excited because SPACEY was buying him drinks and SPACEY had given Will his phone number. Molly said she thought a co-worker was with Will when he met SPACEY. Molly was unsure if Will had ever met any other celebrities at the Club Car while he worked there. At some point during the night,

Molly received a text from Will saying SPACEY was hitting on him, but Molly didn't believe him. Molly said she told Will to walk away. Molly received a Snapchat video from Will showing SPACEY touching the front of Will's pants by his crotch. Will texted Molly again when he was running home and then they spoke on the phone when Will got home. Molly could tell Will was drunk and she felt Will was emotionally worked up. Molly has seen Will drunk before during their relationship. Molly was aware SPACEY had texted Will asking him where he went. Molly wasn't sure if she'd seen the screenshot of it or the actual text later on. Molly felt she and Will were texting late at night and that it lasted about an hour or so throughout Will's ordeal. Will's voice was wavering and he kept repeating, "I'm not gay." Molly felt Will was caught off guard a man would hit on him. Will never told her SPACEY reached into his pants, but she found out later after Heather Unruh's news conference. Molly was asked for more information about the Snapchat video she saw, but Molly said she only ever saw it twice and she wasn't able to give any more description than a hand touching the front of Will's pants. When they spoke, Will told her he was going to wake up his sister Kyla. Molly said a lot of people knew SPACEY had hit on Will, but people didn't know he was actually sexually assaulted. Both their groups of friends would joke around with Will about it and it never seemed to bother Will. Molly was asked if there were any other pictures or videos from that night to which Molly responded no. Molly said she did receive the autograph Will had SPACEY sign. Molly said she couldn't read it and it was on a torn piece of paper. Molly said she doesn't even know where it is. Molly said no one else has attempted to speak with her about this other than family and friends after Heather Unruh's news conference. Molly is still close with the Littles and she saw Will over Thanksgiving break. She knew at that time Will had filed a police report. Molly had seen Heather Unruh's Facebook post prior to the news conference so she knew what was coming. Molly was asked if she and Will were involved in a private text or a group text. Molly was only part of a private text with Will and herself.

3. The interview ended at approximately 3:25PM.

- 1. On Monday, December 18, 2017, at approximately 4:46PM, Sergeant Brightman and I interviewed Kyla Little (DOB: 4/11/00) at 27 Bretton Rd, Dover regarding her interactions with her brother, Will Little, after he was allegedly sexually assaulted by Kevin Spacey Fowler, hereinafter referred to as SPACEY. Kyla gave us the following account:
  - a. Kyla was on Nantucket the summer of 2016 working at Pinwheels and staying with her grandmother and Will. She last spoke to Will the night before on July 6th because she worked during the day and he worked at night. Kyla had gone to bed at approximately 10PM on the July 7th. Sometime during the early morning hours of July 8th, Kyla awoke to Will sitting on the end of her bed breathing heavily. Kyla was asked if Will's behavior was unusual and she said it was. They both have different bedrooms. Oftentimes when Will came home he would make a burger outside on the grill. Kyla remembered Will saying, "Kevin SPACEY just raped me." Kyla said Will seemed flustered. Will started pacing back and forth before sitting on the extra twin bed and telling Kyla what happened between he and SPACEY. Kyla was told Will learned from his friend Nic that SPACEY would be there. Will started talking with SPACEY and they went from drinking whiskey to beer. Then SPACEY started reaching into Will's pants. I asked if Will specifically said "into his pants" to which Kyla said Will definitely said SPACEY put his hand "in his pants". Will told Kyla SPACEY wanted him to go to an after party. At some point, SPACEY went to the bathroom and a woman told Will to run. After Will told her what happened, she called her mother and they both spoke to her. Will also showed Kyla the napkins SPACEY had signed. Kyla said the conversation with Will was between 2AM and 3AM. Will went to bed after

they were done talking and according to Kyla, it was obvious Will was drunk. I asked if Kyla had seen Will drunk before and Kyla stated she had. Kyla got Will a glass of water and then went to bed. The next day she got up and went to work at Pinwheels. Kyla recalled Will using the term "rape" a lot when he talked about what happened. Will seemed completely flustered and confused about how it happened. He had wide eyes; looking everywhere. He was sweating, but Kyla said it was July and he had just run home.

Kyla told us she thinks it affected Will, but he's been able to laugh about it which is probably a coping mechanism. Kyla added the laughing was more immediate and recently it's been less so. Kyla's noticed since Will reported it and he's been home, he's been acting different; more quiet than usual. Kyla said Molly Doyle felt the same way about Will's behavior.

2. The interview ended at approximately 5:12PM.

#### TELEPHONE INTERVIEW OF JOE PANTORNO:

I spoke with Joe Pantorno on Tuesday, December 12, 2017 at approximately 3:33PM. Joe was the owner of the Club Car during the summer of 2016. Joe told me the following:

Joe doesn't have any independent memory of that night, but knows Kevin SPACEY was there at some point. The Club Car gets very busy on Nantucket in the summer and he couldn't isolate one night from another. He vaguely remembers SPACEY being there. Joe said he did not see SPACEY assault anyone and no one talked to him about it happening.

#### TELEPHONE INTERVIEW OF DAVID POWELL:

I spoke with David Powell on Tuesday, December 12, 2017 at approximately 6:05PM. David told me the following:

He was working as a bartender at the Club Car on the night of July 7, 2016 into July 8th. He remembers Kevin SPACEY coming in with two other guys, but David didn't recognize the two guys. SPACEY sat at the bar for a couple of drinks. David knows Will Little from working at the Club Car with him. David did see Will hanging out with SPACEY. From David's perspective, it didn't seem like SPACEY was too bothered by hanging out with Will. David was going to tell Will to leave SPACEY alone, but did not. Last he saw, they were near the piano. David did not see if Will was drinking. If he had, he would've put the "kibosh" on it. David said it was unusual to see Will near the bar. David

did not see SPACEY assault or sexually assault anyone that night. David heard about Will's story from the paper. David described the Club Car that night as a normal, crazy night other than SPACEY showing up. He said every night was like Saturday night in the summer.

#### TELEPHONE INTERVIEW OF CLAUS BOKELMAN:

I spoke with Claus Bokelman on Tuesday, December 19, 2017 at approximately 12:50PM. Claus told me the following:

Claus knows Will Little because Claus was a waiter at the Club Car. Claus saw SPACEY at the bar. Claus never saw Will with SPACEY, but the talk amongst the staff was Will was with SPACEY. Claus offered his own opinion that the whole thing was blown out of proportion. Claus worked that night until about 11:30PM. After his shift he would've stayed outside and in the employee area. When Will came back to work everyone was joking about it to include Will.

#### TELEPHONE INTERVIEW OF NIKOLA UZELAC:

I spoke with Nikola Uzelac on Thursday, December 21, 2017 at approximately 2:47PM. Nikola was in Serbia and it was 8:47PM where he was. Nikola told me the following:

Nikola does remember when Kevin SPACEY came to the Club Car. There were three times that summer, with the first visit being when Will met him. Nikola wasn't working that night, but was there with a friend. Nikola said he didn't see an assault. He saw SPACEY close to Will. Nikola had eyes on them all night. He thought something was going on that night between the two of them, but didn't see any groping. Before Will met SPACEY, Nikola had been sitting near SPACEY and then they spoke when SPACEY heard Nikola was from Serbia. Will came over and it was obvious he was starstruck and excited about meeting SPACEY. Nikola said again he did not see the act, but he knew Will as a good guy and really funny. But something happened and Will looked pale, blank, a bit frightened. Nikola said, "To be honest, I was drinking that night." Will had come over to the bar after his shift where SPACEY was sitting with two other guys near where Nikola was sitting. Earlier, when Nikola went to the bar, he saw three seats reserved so he knew someone important was coming in. That's when he found out SPACEY was supposed to show up. When Will came over he was looking for SPACEY. Later in the night, Will and SPACEY were sitting in the farthest place from the bar where there wasn't much light. There were 6-10 people around the piano. Nikola said they were sitting close to each other. Sometimes people would block his view of them and they were there for 5 to 10 minutes. Nikola said he was still with his friend when he noticed Will didn't seem like himself. Then Will was gone, but Nikola saw SPACEY again. Nikola found out the next day what happened, but couldn't remember who told him, whether it was the staff or a bartender. Will spoke about it over the next couple days. Nikola heard Will was either groped, sexually harassed, or raped. Nikola stated again Will was a good guy and not a liar.

#### TELEPHONE INTERVIEW OF KERRY FEE:

I spoke with Kerry Fee on Thursday, December 21, 2017 at approximately 3:10PM. Kerry said she didn't start working at the Club Car until the middle of July during the summer of

2016. Kerry added she does remember seeing Kevin SPACEY at the Club Car from other summers.

#### TELEPHONE INTERVIEW OF PEGGY FELDON:

I spoke with Peggy Feldon on Friday, December 29, 2017 at approximately 12:02PM. Peggy told me the following:

She worked as a bartender at the Club Car. She remembered Kevin SPACEY was in a couple of nights and does remember a "busser" named Will. On the first night SPACEY was at the Club Car, all the staff went to the bar to "peek" at SPACEY. Peggy described them as "star-struck". Peggy did not remember if Will was one on one with SPACEY. Peggy recalled SPACEY ordering a martini called "blood in sand" and described it as an "old school" martini. Peggy did not know how to make the drink so the other bartender, Dave, made the drink for SPACEY. SPACEY was at the bar interacting with people. Peggy did not see any type of sexual assault take place involving Kevin SPACEY.

#### TELEPHONE INTERVIEW OF JENNIFER FLYNN:

I spoke with Jennifer Flynn on Tuesday, January 3, 2018 at approximately 11:31AM. Jennifer told me the following:

Heather Unruh reached out to Jennifer via her LinkedIn account. Heather had discovered Jennifer was at the Club Car the night of January 7, 2016 through an Instagram account. Heather had asked Jennifer to see if any of her friends who were with her had seen Kevin SPACEY interact with Will and/or had told Will to run. Jennifer said she came up empty. She asked her friends and they didn't see anything out of the ordinary. Kevin SPACEY was not the focus for her that night. She remembered someone pointing out SPACEY and when she glanced over she might have seen the back of his head. Jennifer did not try to meet SPACEY. Her group of friends were near the piano while they were at the Club Car. They had not eaten at the Club Car, but gone there after dinner elsewhere for drinks. Jennifer described the Club Car as busy and that it's not unusual to have famous people on Nantucket.

- 1. Heather Unruh identified the piano player in the Club Car on the night of July 7th into July 8th, 2016 as Brian Buch (DOB: 8/19/84). According to Heather, Brian Buch did not see what was happening that night, but he went to Florida for a wedding and saw Dave Powell recently. According to Heather, Dave told Brian he saw everything that happened and Dave saw the woman that told Will Little to leave the Club Car after Will told the woman Kevin SPACEY was trying to rape him.
- 2. I called Brian Buch and spoke to him on Wednesday, January 24, 2018 at approximately 5:50PM and learned the following:

Brian doesn't remember seeing Kevin Spacey in the Club Car that night and he has no independent memory of that night. He had no idea anything was happening or had happened. After the incident, Brian remembers both the owner, Joe Pantoro, and Will talking about it at the next staff dinner. Joe said at the dinner that Kevin Spacey was a little "touch-feely and flirty" and that he thinks Kevin Spacey "has a thing for one of our bus boys." Will said something along the lines of, "if that guy wasn't famous, I would've punched him." Brian felt Will may have been star struck.

Brian saw Dave Powell, the bartender, about two weeks ago. Dave said he saw SPACEY and Will go in another room. I asked what room and Brian said it was from the bar area to the dining area. That appeared to be the extent of Brian and Dave's conversation regarding the incident.

Brian said he had spoken with Heather Unruh on Wednesday, January 17, 2018 for approximately 5 minutes.

Brian had to end our conversation because he needed to give a piano lesson, but he called me back on Thursday, January 25, 2018 at approximately 3:08PM. Brian told me he witnessed Kevin SPACEY touching a male who was celebrating his 21St birthday. Brian was done working and sitting in the back corner of the bar area. SPACEY was at the bar where the bartender would be. To the left of SPACEY was the man and to the right of SPACEY were the man's parents. SPACEY was talking to both the man and the parents, but while doing so was touching the front of the man's pants "pretty aggressively". Brian originally thought SPACEY and the man were dating. Brian added when Will Little's story came out he thought it was the man at the bar the press were talking about. SPACEY was by himself that night as Brian didn't see him come in with anybody and SPACEY left by himself. Brian said he didn't see SPACEY's hands go in the man's pants and it was all in the front of his pants. Brian said he was about 10 feet away from the bar where they were.

I asked Brian if he'd heard about any women saying they were the woman that Will spoke to and Brian said he did not that woman nor had he heard anything about her.

1. On Wednesday, March 7, 2018 at approximately 11:08AM, I spoke with Joseph "Joe" Pantorno (DOB: 6/14/50) related to the investigation of an Indecent Assault and Battery on Nantucket. Joe was the owner of the Club Car on Nantucket during the summer of 2016 where the alleged sexual assault occurred. I had already spoken with Joe on December 12, 2017 regarding his knowledge of the incident. Joe told me the following:

He had spoken to Sergeant Klinger (Nantucket Police Department) previously and again recently about the Club Car reservation book. Everything was manual, not computerized, and since Joe didn't own the Club Car anymore, it was all at the dump. He only kept the tax copies which was at the direction of his accountant. He used to keep his receipts in the basement, but they too, went to the dump. Joe explained it was a seasonal restaurant where it wasn't computerized and he kept everything in boxes. There was mildew in his basement so that was his reason for taking the boxes to the dump. Joe said after the news broke about the sexual assault, he received a call from his insurance company. Joe remembered that the staff was joking with Will about Kevin SPACEY the next day. He also remembered seeing Will over the summer of 2017 where he joked with Will about Will seeing any SPACEY movies. I asked if Joe had heard of the woman that Will may have spoken to and Joe responded he knew nothing about a "mystery woman". I also asked if the Club Car cordoned off seats at the bar and if they did it for SPACEY. Joe said they would do that, but only in the early evening for dinner before the music starts.

2. The interview concluded and Joe agreed to speak to me again if need be.

I asked Steve if there was an attitude on the island to close ranks and not talk about the alleged sexual assault, but Steve said his opinion was to the contrary and if he heard anything of value, he would pass it on to me.
