16 The Orders of 2002 and 2006 are modified as follows:

17 1. Subject to Paragraph 4, commencing August 1, 2010 and continuing until  
18 the earliest of the minor child reaching 18, as possibly extended by Family Code section  
19 3901 to not later than June 2016, dies, marries, becomes emancipated, becomes self-  
20 supporting, or further order of court, Respondent shall pay to Petitioner child support in the  
21 sum of \$100,000 per month. Commencing July 2016, if the factors set forth in Family  
22 Code section 3901 apply, then until the first to occur of age 19, graduation from high  
23 school, the minor no longer being a full-time student, or no longer living with Petitioner full-  
24 time, the child support shall be reduced to \$50,000 per month for this period.

25 2. Subject to Paragraph 4, Petitioner shall pay all expenses of the minor  
26 (excluding uninsured health care expenses which shall be paid half by each party)  
27 including, but not limited to, school expense, equestrian expense, clothing, housing, travel,  
28 hobbies, automobile, food, beauty treatments, tutoring, entertainment, parties, pets,

2 3. Subject to Paragraph 4, as and for payment of retroactive child support,  
3 Respondent shall pay to Petitioner the sum of \$100,490.19 per month for 102 months,  
4 resulting in a total payment for retroactive child support of \$10,250,000 payable by  
5 Respondent to Petitioner upon the satisfaction of Paragraph 3.a. of the Settlement  
6 Agreement and Mutual General Release signed by the parties on July 8 and July 9, 2010.

7 4. This Stipulation is effective only upon the satisfaction of Paragraph 3.a. of  
8 the Settlement Agreement and Mutual General Release signed by the parties on July 8  
9 and July 9, 2010.

10 5. Each party shall pay his and her own attorneys' fees and costs, except that  
11 the \$489,254.04 previously paid by Respondent to Trope & DeCarolis, LLP is not  
12 recoupable and is deemed fully earned.
