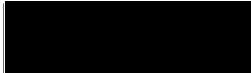



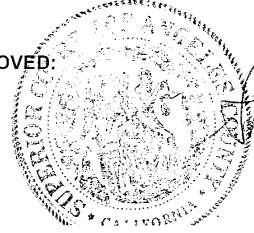

Location #1 The premise is located at [REDACTED]; described as a one-story beige and brown structure.

Location #2 The premise is located at [REDACTED]; described as a tan one-story structure with the number [REDACTED] on the curb in front of the vehicle.

4 **Statement of Probable Cause:**

5 Affiant declares under penalty of perjury that the following facts are true and that there is probable
6 cause to believe, and Affiant does believe, that the designated articles, property, and persons are
7 now in the described locations, including all rooms, buildings, and structures used in connection
8 with the premises and buildings adjoining them, the vehicles and the persons:

10 I, your Affiant, Leanne Hoffman , serial number [REDACTED] have been employed as a Police Officer by
11 the Los Angeles Police Department for the past seven years. From May 2007 to December 2007 I
12 was assigned to 77th Vice unit. I was tasked with investigating and filing cases including but not
13 limited to Pimping, Prostitution, and ABC violations. From December 2007 to January 2009, I was
14 assigned to the 77th Street Gang Enforcement Detail (G.E.D.). While working G.E.D., I was tasked
15 with gathering intelligence, monitoring, documenting and suppressing of various street gangs. From
16 December of 2008 to May 2009 I was assigned to the 77th Street Area Detective Division, Gang
17 Impact Team, Investigations Section. As of May 15, 2009 to current I have been promoted and
18 currently work as a Detective for the Hollywood Major Assault Crime and Crimes against Persons
19 table. My caseload working the Gang Impact Team and the MAC/CAPS table includes the
20 investigation of hundreds of violent crimes, including, but not limited to, murders, attempted
21 murders, assault with deadly weapons, robberies, and various felony and misdemeanor crimes.

25 On 11/26/09, Jasmine Lennard reported a burglary that occurred between the dates of 10/15/09
26 through 11/17/09. Lennard was on vacation in London and upon returning noticed items missing

1 from the residence. On 11/26/09 she was told by a mutual friend that "Casey Johnson" aka Sale
2 Case Johnson had possession of some of her clothing. The victim then reported the incident to
3 police.
4
5 On 11/30/09 I, Detective Hoffman and Detective Ramirez #25992 went to the residence of Casey
6 Johnson. [REDACTED] In plain sight on a table inside of the
7 residence was a pink purse which matched the description of one reported stolen by Lennard. Upon
8 speaking with Johnson she agreed to return the item she had taken from Lennard's home. Johnson
9 refused to let detective's into her home to conduct a search but instead placed several items,
10 including ones not reported as missing, in several bags. Johnson was subsequently arrested for 487
11 (a) PC, Grand Theft and transported to Van Nuys for booking. Upon speaking to the victim,
12 Lennard, she stated that there were still items outstanding.
13
14
15 On 12/09/09 an urgent message was left on my voicemail by Lennard asking for me to return her
16 phone call. On 12/10/09 I spoke to Lennard in which she stated that "Casey Johnson" had appeared
17 at a red carpet event and was wearing her dress. I was able to "Google" the name "Casey Johnson"
18 and received numerous photos of Johnson with Tila Tequila. The photos were taken at the "Stars
19 and Straps" party which was on 12/08/09 beginning at 2100 hours. Johnson was wearing a gold
20 dress which appeared too big for her. Lennard is 5' 07 and 125 lbs and Johnson is 5'03 and only 102
21 lbs. The articles indicate that both Johnson and Tequila have currently become engaged to be
22 married.

SEARCH WARRANT AND AFFIDAVIT

1 I was able to find a video of Casey Johnson and Tila Tequila in bed which was recorded on 12/09/09
2 on ustream.tv/recorded/2752605. Tila Tequila is known for recording web cam videos for the
3 internet on her sight "tilashotspot.buzznet.com" as well as updated "Tweets", electronic messages
4 from a phone or computer, on twitter.com/officialtila. Based on the day (12/08/09) and time of the
5 event (2100 hours) Johnson and Tequila were photographed at and the and the day (12/09/09) and
6 early morning hours the video of the two of them in bed was recorded Johnson spent the night at
7 Tequila's residence. Tila states several times on her Twitter account that Casey Johnson is either at
8 her house or on her way over to her house.

9
10 On 12/11/09 Detective Hoffman spoke to San Diego Police Department Lieutenant, Scott
11 Abarrondo. He stated that a report made by Tila Tequila indicates her address as 3387 Wrightwood
12 Drive in Studio City. I also spoke to Detective Carlton who stated that on 04/16/09 Tila Tequila
13 made a report of a criminal threat. He met with Tequila at the address of [REDACTED] to
14 and spoke with her regarding the investigation.

17 On 12/11/09 I spoke to Jasmine Lennard who alerted me to a Twitter post on Tila Tequila's Twitter
18 account. The post states "...she (Casey Johnson) got me another 2 carat PINK DIAMOND
19 RING!!!!!" Lennard stated that the ring is her ring. She stated that is a not a real diamond but a
20 piece of costumer jewelry that has sentimental value. She stated the ring had a pink square
21 "diamond" with two clear stones on the side of it. In my opinion the remaining outstanding property
22 will be found at the home of Sale Case Johnson or her fiancé, Tila Tequila.
