Peckham, Esq. indicating that defendant Dr. Conrad Robert Murray through his counsel has notified the Nevada and Texas Medical Boards of this Court's Order of 11 January 2011 imposing a bail condition that Dr. Murray cease and desist from the practice of medicine in California and suspending his license to practice medicine in California during the pendency of the captioned case.






