Before me this date personally appeared **Campos, Jose 8625** who being first duly sworn deposes and says that on 2/ day of 9/, 2011 (year), at **Weston Florida** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:
The Defendant / Manuel Ramirez b/m (05/30/72) did actually and intentionally touch or strike the victim his wife, Juliana Ramirez w/f (08/15/79) against her will and in doing so, did commit the crime of battery contrary to Florida Statue 784.031(a)1.

On Monday 09/12/2011 at (1635) hours, I responded to the location of [REDACTED] in the city of Weston In reference to a domestic violence incident. Dispatch advised that victim was hit in the face by the husband and had a bump of her head.

Upon my arrival, I met with the victim, wife, Juliana Ramirez who advised that she and her husband, Defendant, Manuel Ramirez b/m were involved in a dispute that escalated. The victim advised during the dispute the defendant struck her in the left side of her face with an open hand causing her to hit her head against the headboard of the bed. Probable Cause Affidavit

Before me this date personally appeared Campos, Jose 8625 who being first duly sworn deposes and says that on 2/ day of 9/, 2011 (year), at Weston Florida (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:
incident occurred while both parties were in the master bedroom and were both on the bed.

The victim advised she was afraid that the situation might escalate further so she promptly called the police. I also spoke to the defendant who advised that he was in a dispute with his wife however he stated that he grabbed his wife by the shoulders and when he shrugged her, she hit her head against the headboard.

Concluding my investigation, I was able to determine that the defendant was the primary aggressor in this incident.

The victim was observed to have sustained minor injuries and as a result she did refuse medical attention. The victim sustained red swelling on the left side of her face and also had a small contusion on the back of her head consistent with what she stated.

The victim will be provided with a Domestic Violence Pamphlet, Bso vine form, case number and video. Both parties were photographed however they both refused to cooperate and give a taped statement.

The defendant was then taken into custody and was charged accordingly. The defendant was transported to the District Office and then to the Davie Jail for processing.

Shift Supervisor Sgt Japes was apprised of the incident . No further information to provide at this time.
