On October 28, 2009, I, Dep. Thorpe of the Lee County Sheriffs Office was dispatched to 12995 Cleveland Ave. Ft. Myers, Florida, Lee County Sheriffs Office substation, ECHO district, in reference to a sexual battery.

Upon arrival, I made contact with victim/ complainant, [REDACTED] stated that she was walking with her friend/ acquaintance, H/M Johan Santana DOB 3/13/79, on the golf course at the Renaissance gated community at approximately between 2100 hours to 2230 hours on October 27th 2009.

During the walk, [REDACTED] stated that Johan began to kiss her and pull up her top, unclasping her bra. [REDACTED] stated to Johan that she did not wish to have sexual relations with him at this time. Johan ceased for a moment and continued to pursue [REDACTED]. Johan began to pull at [REDACTED] skirt/ skort and attempt to place his hands into her underwear. [REDACTED] stated she told Johan no multiple times but Johan persisted. Johan placed his hands into her skirt/ skort, under her underwear and penetrated her vagina with his finger/digit. Johan then pulled [REDACTED] skirt/ skort off although [REDACTED] rejected his efforts. [REDACTED] then stated that Johan took his pants off, turned her around and inserted his penis into her vagina. [REDACTED] advised that she continuously told Johan "No". Johan grabbed her right calf and extended it while also grabbing her by the hair while he vaginally penetrated her. [REDACTED] has a bruise where Johan grabbed her calf. Johan removed his penis and ejaculated on her upper thigh.

[REDACTED] cleaned her thigh with her underwear and placed it into her bra. [REDACTED] placed her skirt/ skort back on and walked back to the tennis court area with Johan.

[REDACTED] went to the restroom at the tennis courts and noticed she had placed her skirt/ skort on inside out. She removed it and placed it on correctly.

[REDACTED] continued to sit at the tennis courts as Johan played tennis with another person.

[REDACTED] returned to her residence and washed her face.
