STATEMENT OF PROBABLE CAUSE

Your affiant is Jose Viramontes. I have been employed as a law enforcement officer for the Los Angeles Police Department for the past 21 years. I have been a detective for approximately nine years. My primary assignment is to investigate cases wherein an individual(s) demonstrates an abnormal fixation and generate a long-term pattern of harassment, threats, stalking, unsolicited act of visitations, unsolicited telephonic communication, unsolicited electronic written communication (E-mails), in an annoying manner toward a person within the City and County of Los Angeles.

While working **TMU**, I have conducted or assisted in numerous investigations involving stalking and its related offenses. I have also attended the **Threat Management Conference** for the past three years, which provided various multidisciplinary courses pertaining to stalking and criminal threats.

Previous assignments as a detective include, three years at Rampart Detective Support Division. While at Rampart Detective Support Division, I worked Major Assault Crimes (M.A.C.), Crimes Against Persons (C.A.P.S.), Juvenile Investigations, Sex Crimes, Robbery Investigations and the Gang Unit.

During their short dating relationship, the victim received much unwanted publicity and her image appeared on tabloid magazines. Due to that fans. The victim travels from Georgia to Los Angeles for business and is concerned the suspect may actually carry out the threat.
