On TUE 07 MAR 17 at 1323 hrs. R/Os SEATON 1768 and OSEKA 1781 along with other Northeast officers were dispatched to 7414 North 30th St. reference a crowd disturbance in the parking lot with 20-30 people. R/Os were informed that a armed party was Southbound on North 30th St. in a black SUV with Nebraska plate UEY 465. That vehicle was stopped and cleared and after that R/Os went to the original scene and spoke with victim WAKEFIELD, Mystery. WAKEFIELD stated that she was at work at Citi Trends at 100 hrs. when two unknown black females entered the store and wanted to fight her. WAKEFIELD stated the females were escorted out by management. At approx 1320 hrs. another black female enter the store and wants to fight WAKEFIELD. WAKEFIELD knew that female as "IESHA" who is CRWAFORD, Terrance's sister. WAKEFIELD stated she clocked out from work and went outside. At that point "IESHA" starts fight with WAKEFIELD and during the altercation WAKEFIELD's finger gets bit by "IESHA". WAKEFIELD states more females show up and at some point an independent female party yells and the fight breaks up and all parties get back into vehicles and leave the area.
