I, KATHERINE JACKSON, under penalty of perjury, hereby declare that I will appear at trial and testify the following information to be true, accurate and correct:

1. I am the Mother of Michael Joseph Jackson, who is deceased, the current legal guardian of his three young children; Michael Joseph Jackson Jr., (Prince) Paris Michael Katherine Jackson, Prince Michael Jackson II (Blanket) and together, we make up 80% of the Plaintiff's; Estate of Michael Jackson's beneficiaries. The other 20% is to go to a selected charity.

2. Further, I was designated in my son's trust, (see ex.9 article 3 paragraph 1, attached hereto) to be a part of the committee of authorized persons that would make the decision on what charity would become the beneficiary of that 20%, however, against my expressed wishes, I have been completely excluded from any decisions concerning this issue or any other decision pertaining to my son's estate.

3. "As soon as reasonably practical after the death of the Trustor, the trustee shall distribute a sum equal to twenty percent (20%) of Trustor's gross estate, as valued for federal estate tax purposes, to one or more charities for the benefit of children, and/or children's causes. The recipient charities shall be selected by a committee consisting of JOHN BRANCA, JOHN McCLAIN and KATHERINE JACKSON (herein, the "Committee") Nearly two years after my son's death, the estate's funds are being used to hire lawyers that suppress my
